Superintendent's Message

Parents, Students and Community members:

Welcome back to the 2018-19 school year at Cherry Valley-Springfield Central School! Students, I hope this is your best year yet! The consistent buzz I hear everywhere is students and adults getting ready for another year. Secondary students are asking about their schedules and the elementary students are eager to select their school supplies. Soccer practices have started and the school itself is getting busier by the day with teachers getting ready for a fantastic year.

We have taken the summer to reflect on our successes and also on what we need to improve on as a district. One of our overall concerns is mental health. We will be spending time exploring mental health and what that means as a school district. Our opening conference day will start with an introduction to trauma awareness in our schools. Our goal is to work with our students and families so that we can support those in need and be mindful what our students deal with on a daily basis.

We have spent the spring and summer focusing on issues where we need improvement. With that being said we have made changes to our attendance policy, cell phone policy, academic eligibility policy and afternoon dismissal. We will be reviewing these policies at Open House on Wednesday, September 19, 6:00-7:30 p.m. Open House will begin in the auditorium to review the changes, introduce new faculty and staff, and share our expectations.

Attendance Policy: Students in grades 9-12 will be held accountable to not surpass 28 absences for a full-year course or 14 absences for a half-year course. A process of how students and parents will be notified has been developed so that everyone is aware when students reach specific benchmarks.

Cell phone policy: We have found cell phones to be a major distraction in the learning process and to our students overall health. Students will not be allowed to use their cell phones from 7:45 a.m.-2:53 p.m. Consequences include a warning, cell phone brought to main office and student can pick up at the end of the day and/or parent pick up at the end of the day.

Academic Eligibility Policy: A shared decision team met over the summer to make recommendations to the present policy. Grades will be reviewed at every 5-week notice and report card dates. Students who are failing two or more classes we be considered ineligible. Students will be required to meet with their teacher to create an academic improvement plan. For the next five weeks the student has the opportunity to prove that they are passing by submitting an eligibility sheet signed by their teachers that they are not failing two or more classes. If they are not failing two or more classes they will be eligible for that week. Students will need to complete this form every week to show they are passing.

Afternoon dismissal: We have found that more and more students do not know where they are going after school or parents are calling after 1:00 p.m. to make changes. We will no longer accept changes after 1:00 p.m. It is imperative that students know where they are to go after school. All notes of any changes should be sent in with your student in the morning. Please refrain from calling the office to make the change. We have put in a new process of tracking changes and to get bus rosters updated on a daily basis for the drivers. Safety is our ultimate concern. For anyone who comes to the office at the end of the day has seen how chaotic it is. Buses WILL NOT be held to find out where a student is to go. The student will go to the after-school program. We will call after the buses have left to notify the parent of the situation. The parent will have to come pick up their child or ride the late bus home at 5:00 p.m.

We have a few new faces to welcome to our school this fall. Our new cafeteria manager is Melissa Davidson. In 3rd grade we have Jessika Bartlett, 4th grade Rebecca Sniffen and 6th grade Jessica Chapman. Crystal Pierce will be joining our Physical Education Department. We welcome them and are excited to have them join our CV-S family. Our next newsletter will include a photograph and a little information about them.

Our teachers have been in over the summer working on curriculum and initiatives. The HS gym has been resurfaced and it looks amazing! The hallways have been waxed and all we are missing are the students. I encourage you (parents and community members) to get involved in the school. Volunteer, attend our events, or stop by my office for a chat. Please know that you are always welcome.

In closing, I hope that you have had an enjoyable summer. Please take the time to go through the newsletter as it contains useful information. We are looking forward to September 5, when the students return to CV-S. Until then, enjoy the remaining days of summer vacation.

Tardiness to School

Students are considered late if they arrive after 7:58 a.m. When a student is late to school it is the responsibility of both the parent and student to account for that tardiness by submitting a note. The note must include:

- 1. Date and time of arrival;
- 2. Valid reason for tardiness; and
- 3. Signature of parent or guardian with a number where they may be reached during the day.
- **3rd unexcused tardy** in a marking period: Student is assigned a lunch detention for the day he/she is tardy.
- **4th unexcused tardy** in a marking period: Student is assigned a lunch detention for the day he/she is tardy.
- **5th unexcused tardy** in a marking period: Student is assigned a lunch detention for the day he/she is tardy.
- **6th unexcused tardy** in a marking period: Student is assigned after school detention from 3:00 p.m. until 5:00 p.m. for the day he/she is tardy.

Every unexcused tardy thereafter will result in after school detention on the day the student is tardy. Failure to comply with these consequences will result in further disciplinary action.

The School District has determined that absences, tardiness and early departures will be considered **excused** or **unexcused** according to the following standards:

• **Excused:** An absence, tardiness or early departure may be excused if due to personal illness, illness or death in

the family, impassable roads due to inclement weather, religious observance, quarantine, required court appearances, attendance at health clinics, approved college visits, approved cooperative work programs, military obligations, music lessons, or other such reasons as may be approved by the Board of Education.

• Unexcused: An absence, tardiness, or early departure is considered unexcused if the reason for the lack of attendance does not fall into the above categories (e.g., family vacation, hunting, babysitting, haircut, obtaining learner's permit, road test, oversleeping).

We appreciate your support of our efforts to improve attendance.

Use of Facility and Grounds

The Board of Education allows groups and organizations to use the Cherry Valley-Springfield Central School Building and Grounds providing that certain requirements and guidelines are met. These requirements and guidelines are set not only for avoiding scheduling conflicts but to ensure proper security, safety and building maintenance measures.

A copy of the full context of the requirements and guidelines is available by contacting the Main Office.

Attendance

If your child is going to be absent, please call the Health Office the morning of the absence. When you call, please leave your name, the student's name and grade and the reason for the absence. If no reason is given, it will be marked as an illegal absence. Voicemail is available so you may leave a message during the night. The number is 264-3265, ext. 514. Please remember to follow-up with a written note to be turned into the Main Office for the absence.

Parents of Home-Schooled Children

Annual Fire Inspection

Asbestos Notification

The CV-S Building and Grounds do not contain asbestos materials.

Electronic Surveillance

Cherry Valley-Springfield uses video equipment to assist in building and transportation safety and security. Cameras are placed at entrances and hallways, both inside and outside of the building. There are also cameras on the schoolowned buses. The purpose of the cameras is primarily building security and safety, but students and parents must be informed that the video footage is sometimes scanned in situations where incidents involving students may have happened. If the camera footage indicates that a child has misbehaved in any way, administration will use those images to give consequences, as necessary.

Homework Requests

When your child is out sick, please contact the Main Office by 9:00 a.m. for homework to be gathered. Please understand that sometimes notes for all classes might not be available that same day. If a child misses class, notes that were on the board will have to be reproduced, that will take some time to do. If your child is absent, we make every effort to have all homework collected. However, remind your child to ask the teacher what else needs to be done to make up all that is missed. Remember that being in school as much as possible is the best way to get it all.

Parent Notification Regarding Teacher Qualifications

In accordance with the federal No Child Left Behind Act of 2001, parents and guardians have the right to request specific information about the professional qualifications of their children's classroom teachers. As a parent/guardian of a student in the Cherry Valley-Springfield CSD, you have the right to request the following information:

- if the teacher has met New York state qualifications and licensing criteria for the grade levels and subject areas he or she teaches;
- whether the teacher is teaching under emergency or other provisional status through which the state qualification or licensing criteria have been waived;
- the teacher's college major, whether the teacher has any advanced degrees and if so, the subject of the degrees; and
- if your child is provided services by any instructional aides or similar paraprofessionals provide services to your child and, if they do, their qualifications.

Requests for information about the qualifications of your child's teacher(s) can be directed to either principal at (607) 264-3265, ext. 506 or 515. All requests will be honored in a timely manner.

Thank you for you continued support and interest in your child's education.

Dissection of Animals

Per Board Policy 4850 and Education Law Part 809, any student expressing a moral or religious objection to the performance of or witnessing of the dissection of animals, either wholly or in part, shall be provided the opportunity to undertake and complete an alternative project that shall be approved by such student's teacher; provided however, that such obligation is substantiated in writing by the student's parent or legal guardian. Students who perform alternative projects who do not perform or witness the dissection of animals shall not be penalized. Parents or legal guardians may contact their child's teacher for further information.

Possible Pesticide Application in School Buildings and on District Property

New York State Education Law Section 409-H and State Education Department Commissioner's Regulation 155.24, effective July 1, 2001, require all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty and staff regarding the potential use of pesticide periodically throughout the school year. In the event of an emergency application necessary to protect against an imminent threat to human health, a good faith effort will be made to supply written notification to those on the 48-hour notification list.

The school district is required to maintain a list of persons in parental relation, faculty, and staff who wish to receive 48-hour written notification of certain pesticide applications. If you would like to receive 48-hour notification of pesticide applications that are scheduled to occur in your school please contact the school.

The following pesticide applications are not subject to prior notification requirements:

- A school remains unoccupied for a continuous 72-hour following an application;
- Anti-microbial products;
- Nonvolatile redenticides in tamper resistant bait stations in areas inaccessible to children;
- Nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children;
- Silica gels and other nonvolatile ready-to-use pastes, foams, or gels in areas inaccessible to children;
- Boric acid and disodium octaborate tetrahydrate;
- The application of EPA designated biopesticides;
- The application of EPA designated exempt materials under 40CFR152.25;
- The use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects including venomous spiders, bees, wasps, and hornets.

School Tax Collection

Public Access to Records

Access by residents of the Cherry Valley-Springfield Central School District to records of the District shall be consistent with the rules and regulations established by the State Committee on Open Government and shall comply with all the requirements of the New York State Public Officers Law Section 84 et seq.

Rules and procedures used are pursuant to Article 6 of the Public Officer's Law and the Federal Family Educational Rights and Privacy Act of 1974, as amended.

Child Find

It is the responsibility of the Cherry Valley-Springfield Central School District Committee on Special Education (CSE) and the Committee on Preschool Special Education (CPSE) to find and identify students residing within the Cherry Valley-Springfield Central School District who may be in need of special education services. If you have noticed that your child is not developing skills such as walking, talking, learning, or playing like other young children, and you suspect that he or she may have a disability, you may wish to make a referral to the CSE or the CPSE. You may do so by contacting Bonnie Georgi, the Chairperson of the CSE/CPSE, at (607) 264-9012. The Chairperson will explain the pre-referral, referral, and evaluation process and describe the eligibility requirements for identification of a preschooler with a disability. If your child is between the ages of birth and three, the CPSE Chairperson will refer you to the Otsego County Early Intervention Program. For school aged children, the Chairperson can explain the many general education supports and services available, as well as the CSE referral, evaluation, identification process, and the State and Federal eligibility requirements for identification of a student with special needs. For additional information please refer to A Parent's Guide to Special Education on the New York State Education Department (NYSED) website.

Section 504 Annual Notice

In accordance with the Rehabilitation Act of 1973 commonly known as §504, the School District hereby notifies disabled children and their parents of the School District duty under the Regulations to §504.

The School District shall provide a free appropriate public education to each qualified disabled child who resides in the School District regardless of the nature or severity of the disability. The School District shall educate each qualified disabled child with children who are not disabled to the maximum extent appropriate to the needs of the disabled child, and shall also ensure that disabled children participate with nondisabled children in nonacademic and extracurricular activities to the maximum extent appropriate. A disabled child shall be afforded an equal opportunity for participation in such services and activities.

The School District shall provide disabled children an equal opportunity for participation in physical education courses, interscholastic, club or intramural athletics.

The School District shall conduct pre-placement evaluations, and shall establish standards and procedures consistent with § 104.35 for the evaluation and placement of children who need or are believed to need special education or related services. Periodic reevaluation shall be conducted of children who have been provided special education or related services.

Placement decisions shall draw upon information from a variety of sources and shall be made by a group of persons knowledgeable about the child, the meaning of the evaluation data, and the placement options. The School District shall establish and implement a system of procedural safeguards that includes notice, an opportunity for the parent to examine relevant records, an impartial hearing with the opportunity for participation by the parent and representation by counsel, and a review procedure.

Bicycle riding is fun, healthy, and a great way to be independent, but be cool when riding!

RULES OF THE ROAD-BICYCLING ON THE ROAD

Bicycles in many states are considered vehicles, and cyclists have the same rights and the same responsibilities to follow the rules of the road as motorists. When riding, always:

- ★ Go with the traffic flow. Ride on the right in the same direction as other vehicles. Go with the flow—not against it.
- Obey all traffic laws. A bicycle is a vehicle and you're a driver. When you ride in the street, obey all traffic signs, signals, and lane markings.
- ★ Yield to traffic when appropriate. Drivers on a smaller road must yield (wait) for traffic on a major or larger road. If there is no stop sign or traffic signal slow down and look to see if the way is clear before proceeding. Yield to pedestrians who are in a crosswalk.
- ★ Be predictable. Ride in a straight line. Signal your moves to others.
- ★ Stay alert at all times. Use your eyes AND ears. Watch out for potholes, cracks, wet leaves, storm grates, railroad tracks, or anything that could make you lose control of your bike. Don't wear a headset when you ride!
- Look before turning. When turning left or right, always look behind you for a break in traffic, then signal before making the turn. Watch for traffic.
- Watch for parked cars. Ride far enough out from the curb to avoid the unexpected from parked cars (like doors opening).

SIDEWALK VERSUS STREET RIDING

The safest place for bicycle riding is on the street, where bicycles are expected to follow the same rules of the road as motorists and ride in the same direction.

- ★ When Sidewalks are Safest: Children less than 10 years old are not mature enough to make the decisions necessary to safely ride in the street and should ride on the sidewalk.
- ★ For anyone riding on a sidewalk:
 - \star Watch for vehicles coming out of or turning into driveways.
 - \star Stop at corners of sidewalks and streets to look for cars.
 - \star Make sure the drivers see you before crossing.
 - ★ Enter a street at a corner and not between parked cars. Alert pedestrians that you are near by saying, "Excuse me," or, "Passing on your left," or use a bell or horn.

Medication Procedure in School Health Offices

In order for any medication (scheduled, over-the-counter, emergency, etc.) to be given in the School Health Office, the following must be provided by parents/guardians.

- 1. A written prescription from the prescribing licensed provider (this may be faxed from the provider's office).
- 2. A written permission from the parent/guardian
- 3. The medication must come in its original container
- 4. The medication container must be clearly labeled with the student's name, the type of medication, dosage, and time to be given.

All of the above must be provided for your student to receive their medication in the school health office!

Over-the-counter medications such as Tylenol, Mortin, Advil, Excedrin, Neosporin, etc. will not be provided by the CV-S School District. If your student is to receive any of these medications, they must be provided by the parent/guardian.

Greetings from the Health Office!

Here we are in August and summer is still just flying by! Pardon this brief interruption of your vacation for some details regarding how your student will best benefit from the school health office in the 2018-2019 school year.

- If your student will require medication within school, the health office requires a written order from the prescribing provider, a written consent from parent/ guardian, and the medication must come in its original and correctly labeled bottle.
- Mandated screenings will be completed for hearing, vision, and scoliosis throughout the school year as required by New York State.
- In accordance with New York State guidelines, your student must be up-to-date on their immunizations prior to beginning school on Wednesday, September 5, 2018. Please refer to the specific guidelines in the next column.


Grade level	Immunization Requirement
Pre-K or K	Up-to-date copy of the immunization record must be sent to the Health Office prior to September.
6th grade	Student must receive one dose of TDaP (tetanus toxoids, diptheria, and acellular pertusis)—mandated on or after 11th birthday.
7th grade	Students must receive one dose of a meningo- coccal vaccine. Please note that your student will need a booster of this vaccine on or after their 16th birthday. *
12th grade	Students must have received 2 doses of meningococcal vaccine with a booster on or after their 16th birthday; OR One dose of meningococcal vaccine with a booster if the student received their first dose on or after their 16th birthday. *

Please notify the school nurse of any new medical diagnoses or allergies.

Please notify the school of any changes in contact information including home phone, cell phone, or address.



Bus Safety

Discuss the following safety rules with your child and ask him or her to learn the bus driver's name. Your child should understand that riding the school bus is a privilege and it may be denied as a result of misbehavior on a bus.

Crossing the Street

Be sure that you can see the driver's eyes and that the driver sees you, too. You should cross at least 10 feet in front of the bus. Wait for the driver's signal to cross and then look both ways. Walk, don't run, quickly across. NEVER cross in back of the bus. Remember, if you can touch the bus you are too close and are in a *Danger Zone*.

Getting on the Bus

- Be on time at your bus stop. Stay back from the roadway until the bus is completely stopped. (Student conduct at the bus stop is the responsibility of the parents.)
- Hold on to the handrail as you get on or off the bus. Be sure to carry a backpack for all your books and papers.
- Take a seat immediately.

Riding the Bus

- Stay in your seat. Keep hands and head inside the bus at all times.
- Be courteous to other riders and to your driver. Do not use profane language. Talk quietly with your friends.
- Do not eat or drink on the bus.
- Absolutely no smoking.
- Do not litter. Help keep the bus clean.
- Keep aisles clear at all times. A package or musical instrument that can be held on your lap is permissible, as long as it

does not obstruct the driver's vision. No glass or animals are permitted.

• Do not play with emergency exits.

• If you see something wrong or unsafe, report it to the driver immediately.

• You may not leave the bus at any scheduled stop other than your own without parental permission and approval.


Always follow the bus driver's instructions. The driver is in full command and is authorized to assign seats if necessary. The driver may explain other safety guidelines during the school year.

When Red Lights Flash-Don't Pass!

To ensure the safety of students when they are riding on school buses, drivers of other vehicles may not pass when a bus's red lights are flashing. Many drivers assume that this law refers only to buses stopped in streets and roadways. However, the law was revised in 1990 to include driveways and school parking areas as locations where buses may not be passed if the red lights are flashing.

Drivers who fail to stop when a school bus has its red lights flashing face costly penalties and can even land in jail:

- First conviction: carries a fine of between \$250 and \$400, a jail sentence of up to 30 days, or both.
- Second conviction: within three years carries an increased fine of between \$600 and \$750, a jail sentence of up to 180 days, or both.
- Third or subsequent conviction: within three years carries penalties of a fine between \$750 and \$850, a jail sentence up to 180 days, or both.


