Superintendent's Message

Dear Parents and Community Members,

It is hard to believe how the time has flown by since I began as Superintendent in July and now it is time for the annual budget vote. When you read this newsletter there will be about eight weeks left before summer recess. Overall, the school year has been productive and students are continuously amazing us. We really do have a great group of students who walk our halls everyday.

It has been a busy year. Besides our focus on raising student achievement, we have been busy working with multiple stakeholders to evaluate where we stand as a district in terms of curriculum & instruction, technology, building and grounds, and the transportation fleet. Our ultimate goal is to look forward and create 3-5 year plans, and with those plans have a vision in place of where we want to be. As with any plan we have to look at our finances. We created a budget that begins to put our plans in action.

On Tuesday, May 16, we will ask you to vote on the 2017-18 budget. This budget provides provisions for technology for both of our students and staff and also professional development for staff. In terms of building & grounds, we feel it would be beneficial to the district to re-establish the head custodian position that was abolished a number of years ago. The budget also includes two new buses; one purchase, one lease. We have put together a long-term plan that will put us on a 7-year purchasing plan with our transportation fleet. In order to reach that plan there will be a combination of purchasing and leasing for the next couple of years. We will continue to include \$100,000 in the budget for minor renovation projects. The next minor project would be the replacement of interior doors throughout the building.

In combination with the budget vote we will have a Capital Project Proposal. Within this newsletter you will find information on the scope of the proposed project, how it will be financed, and how it will affect you as a resident of the Cherry Valley-Springfield Central School District. If, after reading this newsletter, you would like additional information regarding this proposed capital project, please attend the budget hearing or contact me in the district office. I would be more than happy to discuss this with you.

Our annual budget hearing is on Thursday, May 4 at 7:00 p.m. in room 145. I hope all will attend and also remember to vote on May 16 from 12 Noon to 8:00 p.m.

And, finally, I want to take this time to tell you how pleased I am to have spent the past nine months here at Cherry Valley-Springfield. I have found the students, staff and parents welcoming and focused on student achievement. Everyone puts kids first and it shows. It is a school community that I am proud to work in and reside in. I am looking forward to continue advancing our district with always putting students at the forefront of our decisions.

School bus transportation is safe.
In fact, buses are safer than cars! Even so, last year, approximately 26 students were killed and another 9,000 were injured in incidents involving school buses. More often than not, these deaths and injuries didn't occur in a crash, but as the pupils were entering and exiting the bus.

Stay away from the bus until it comes to a complete stop and the driver signals you to enter.
Stay away from the bus until the driver gives his/her signal that it's ok to approach.

Keep a safe distance between you and the bus. Also, remember that the bus driver can see you best when you are back away from the bus.
Have a safe place to wait for your bus, **away from traffic and the street.**

When being dropped off, exit the bus and walk ten giant steps away from the bus.
Use the handrail to enter and exit the bus.
Protect yourself and watch out!

Be aware of the street traffic around you.
Drivers are required to follow certain rules of the road concerning school buses, however, not all do.

National Agriculture Literacy Week

The week of March 20 was National Agriculture Literacy Week. Volunteers visited our elementary classes during the week and read to the students the story *The Grapes Grow Sweet* written by Tessa DeCarlo. The book was provided to our school through the NY State Farm Bureau and sponsored by the New York State Agriculture in the Classroom Program. Students learned about how grapes grow, their harvest and what products they are manufactured into. Some classes were given samples of both white and purple grape juice to see which variety was liked the most. In addition to the readings, we celebrated National Agriculture Day on Tuesday, March 21, with a special treat for our students. The atrium was converted into a mini barnyard and we were excited to have a rabbit, several dairy goats, a Boer meat goat and even a baby beef cow to help educate our students on some of the agricultural industries in New York State.

Students had the opportunity to get hands on experiences with the animals and ask questions regarding their care and feeding. The high school agricultural students created displays on corn, soybeans, and production animals. Mr. Lamouret and his students spoke to the classes on what products are made from livestock animals and farm products. We have also included photos of the amazing farm stories that the third graders created in the library using Legos. The children have the full stories, including the problems and solutions in their heads.

Thank you to everyone who helped to make National Agriculture Literacy Week a fun-filled and educational experience for our students. A special thank you to those who brought in the animals and shared their knowledge with us including: Junior, **Megan Wilmot** and CVS Alum, Shannon Sears.

Tara Kells-Moore

Tara Kells-Moore, alumni of Cherry Valley-Springfield Central School, today lives in Bangor, Michigan with her husband and three children; Abigail, Madison and Keith. Tara is a Physical Therapist Assistant, a great career, but it was not easy for her to get there. Tara worked through many things during her life before she settled in Michigan. All of her early experiences taught her that there is a world of opportunities out there, you just have to go for it.

Growing up Tara lived in the town of Cherry Valley and attended CV-S in the 1990's. Unfortunately, Tara was faced with the death of her mother at the age of 16. Although the loss was a huge setback, it did not hold her back from working for the life that she wanted. Throughout high school she worked three jobs, took advanced classes, was an athlete and president of the Drama Club. After her mom's death, Tara was taken in by Marilyn Clapper and Barbara and Ted Duesler, who were close friends of Tara's mom. They encouraged Tara to finish school and be all that she had potential to be. With thanks to them, Tara graduated high school in 1994 with an honors diploma.

After graduation from CV-S she attended Herkimer Community College in the Physical Therapy Assistant program and graduated in 1996. Her first clinical instruction was at Springbrook, a residential facility for handicapped people near Oneonta. Tara stated she found it difficult to work there and not be able to take these children home with her. During this employment, she took two students to the New York State Game for the Physically Challenged. Throughout this time period, when money became tight, Tara worked two jobs to pay rent. Her next job was as a traveling PhTA. This was a good job for her because it paid for room, utilities and a car payment. From this experience, Tara became licensed in Missouri, Wisconsin, Ohio, North Carolina, Florida, Michigan, Illinois, and Indiana. She enjoyed this travelling PhTA experience, met many amazing people and learned a great deal of information that she has been able to use throughout her life.

Eventually, Tara changed jobs and began working for Ford Motor Company as a body mechanic. She worked at Ford until the plant closed down in 2003. After the shut down, she returned to the medical field for employment. She worked as a wound care specialist treating ulcers and wounds in outpatient long-term care settings. When her family decided to move to Michigan, she learned that the State of Michigan did not allow therapists assistants to do wound care, so she was not able to be wound care certified. Changing job directions again, Tara became a regional manager for Kindred Rehabilitation and a clinical instructor at Black Hill College. Additionally she has worked as a manager in the long-term care field where she works on financial budgets and hiring employees. As her children became older Tara wanted to become more flexible so she is currently doing Home Health Therapy. Even with all these jobs she participates in, she enjoys traveling in the summer.

Tara is certified as a LSVT BIG, a certification given to a physical or occupational therapist to address the unique movement impairments for people with Parkinson disease. She finds it humbling to help people every day in their homes where they are the most comfortable. Tara is sad that she doesn't get back to the Cherry Valley area very often because "growing up in Cherry Valley was a very grounded experience." As Tara reminisces on her life, she claims that her biggest professional accomplishment was becoming a clinical instructor to teach new students. She is an activist for LSVT BIG and the organization for APTA (American Physical Therapy Association).

If Tara could come back to CV-S and teach a class, she would teach, *Do-it-yourself*, because she was on her own at age 16 and had to figure out how to pay for her own car and college. She hopes her class could inspire others to believe in themselves because as she states, "even if you think you can't, you can." While in high school Tara really enjoyed

her english teacher Ms. Maggie Bouck who still teaches at Cherry Valley-Springfield. Tara has a lot of faith in students who graduate from Cherry Valley because she believes that all CV-S alumni can teach others about small town kindness and caring. She believes the world can be a hateful place and yet when returning to CV-S, it's always the same and people look out for each other.

Tara has become very successful, traveled to many parts of the country and is extremely happy to carry good qualities from small town Cherry Valley into her adult life. While I spoke with Tara she claimed that if she could give advice to the students, she would say, "Work hard and know what you want." She advises all students, that even if life throws you the biggest curve ball, "if you put your mind to it and push yourself hard, you can make anything happen."

A Message from the Board of Education

On behalf of the Cherry Valley-Springfield Board of Education I would like to remind you of the upcoming annual budget vote on May 16, 2017. This year's proposed 0% tax levy was reached with a lot of hard work and discussion between the Board of Education and our Administration. The community is very supportive of the school and according to the State Aide projections the district will be receiving more funds from New York State than originally anticipated so the Board of Education would like to show their thanks for the community support by keeping the tax levy at 0%.

In addition to the annual budget proposition this year we are asking for your approval to lease a 65-passenger bus and to purchase a 65-passenger bus. Both buses are part of our on-going plan that not only provides for our current needs but also looks toward the future. Speaking

of the future, you will also find on the ballot a proposition for a capital improvement project. As we all know too well our own properties and houses are in constant need of upkeep much like our school buildings are and as many of you are aware we have been including the \$100,000 maintenance projects within the actual budget. However, some of the necessary repairs and upgrades require a more substantial financial backing from the district and that is the reason for the capital improvement project. Mrs. Climenhaga will be sharing more details regarding the proposed capital improvement project within this budget newsletter.

As always, we thank you for your continued support of our District.

Propositions to be on Ballot

Proposition One

- To adopt the budget as presented in the amount of \$13,500,708, to authorize the Board of Education to levy and collect the necessary taxes. The Board of Education is hereby authorized to expend the sum of \$13,500,708 as General Fund Appropriation Budget for the 2017-18 school year and to levy the necessary tax. This represents 1.2% budget increase and a tax levy of 0.00%.

Proposition Two—Bus Lease

- Shall the Board of Education be authorized to enter a lease for one 65-passenger bus for a period of 5 years, with the total cost not to exceed \$16,500 per year which will be paid in annual or more frequent installments for a period of up to 5 years? The source of the funds shall be a tax upon the taxable property of the District to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education.

Proposition Three—Bus Purchase

- Shall the Board of Education be authorized to purchase one 65-passenger bus, with the total cost not to exceed \$105,000? The source of the funds shall be a tax upon the taxable property of the District to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education.

Proposition Four—Capital Project

- Shall the following resolution be adopted, to wit: RESOLVED, that (a) the Board of Education (the “Board”) of the Cherry Valley-Springfield Central School District (the “District”) is hereby authorized to undertake a capital improvement project consisting of the construction, reconstruction, renovation and improvements to facilities of the District, including but not limited to the following: (A) the reconstruction of the existing Main Building, (B) the reconstruction of the existing Transportation Building, (C) miscellaneous site work and improvements at each of the two facilities, including preliminary costs and costs incidental thereto and to the financing thereof (collectively, the “Project”), the foregoing to include the acquisition of furnishings, equipment, machinery and apparatus required in connection with the purposes for which such facilities are used, and all ancillary or related work required in connection therewith; and to expend therefor, including for preliminary costs and costs incidental thereto and to the financing thereof, an amount not to exceed the estimated total cost of \$3,120,000; (b) the District is hereby authorized to expend funds in the amount of \$460,700 from the District’s Capital Reserve Fund to finance a portion of such cost, (c) a tax is hereby voted in an amount not to exceed \$2,659,300 to finance the balance of such cost, such tax to be levied and collected in installments in such

years and in such amounts as shall be determined by the Board; (d) in anticipation of such tax, obligations of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$2,659,300, and a tax is hereby voted to pay the interest on said obligations as the same shall become due and payable; and (e) New York State Building Aid funds expected to be received by the District are anticipated to offset a substantial part of such costs, and such funds, to the extent received, shall be applied to offset and reduce the amount of taxes herein authorized to be levied. NOTICE IS HEREBY FURTHER GIVEN that the School District has adopted the findings of Griffith Dardanelli Architects which determined that the undertaking of the Project is a Type II action that will not have a significant effect on the environment and, therefore, no other determination or procedures under the State Environmental Quality Review Act (“SEQR”) is required.



Those include teachers, assistants, aides and other professional salaries, BOCES charges, supplies, textbooks, special education costs, health, guidance, co-curricular activities and athletics. This area also includes transportation expenses directly related to the functioning of the bus garage and the operation of the bus fleet. The program budget is increasing by 2.81%.

Capital Component

The capital budget includes Operations and Maintenance expenses including salaries, fringe benefits, utilities, and supplies directly related to the cleaning and maintenance of the District's building and grounds. This portion of the budget also includes principal and interest costs related to the borrowing for our capital improvement projects. The District receives 81.5% building aid from NYS for this. Purchases for buses is reimbursed by NYS at 61.5% over five years. \$100,000 transfer to Capital Fund will provide funding for interior door replacement project. The program budget is decreasing by 4.09%.

Proposed Budget Q & A

Q: What is the increase in the local property tax levy?

A: Zero, 0.00%

Q: Does the STAR program still exist?

A: Yes, the School Tax Relief Program, which is known as STAR provides a partial exemption from school taxes. All New Yorkers who own and live in their home and earn less than \$500,000 are eligible for a STAR exemption on their primary residence. Exemption amounts are shown below. The Equalization rate, set by the State, and assessments set by township, will affect the exception value. Enhanced STAR provides a larger exemption on the primary residence for people over 65 years of age and who earn less than \$86,000. This exemption requires initial online registration with New York State. If you qualify, you will receive a STAR credit in form of a check, rather than receiving a property tax exemption. If you or spouse recently turned 65, or if your income fell below \$86,000 due to changing circumstances, please apply online.

Q: How are your dollars spent?

- A: By state law the budget is divided into three categories:
- **Program—70.9%:** This category includes expenses for the instruction and transportation of students.
 - **Capital—19.6%:** This category includes capital improvement and operations and maintenance costs.
 - **Administrative—9.5%:** This category includes costs for administration, supervision and legal services.

Q: How is education funded at CV-SCSD?

A: State aid covers approximately 57% of our expenses. Property taxes cover an additional 38% and other sources cover the remaining 5%.

Q: What is the difference between the State Aid we received last year versus the State Aid we will be receiving this year?

A: The District anticipates receiving approximately 5% more aid for the 2017-18 school year. This is mostly from gains in Foundation and Transportation Aid.

Q: What has been done to reduce the budget to its present level and limit the taxes?

A: The Board of Education at Cherry Valley-Springfield CSD works hard to balance the needs of the students and the taxpayers' ability to pay. We have put together a budget that is fiscally responsible and that sustains our educational programs. The district continues to be efficient with the following efforts: bringing services back into the district, sharing maintenance and transportation staff, and exploration of grant opportunities.

Q: What happens if the budget is voted down?

- A: If the proposed budget is voted down the Board of Education has three choices.
1. They can adopt a contingency budget.
 2. Put the same budget before the voters for a second time in June.
 3. Revise the defeated budget and put that budget up for another vote in June.

Q: What is a contingency budget?

A: A contingent budget is a budget that includes the minimum funds necessary to operate and maintain schools and educational programs, preserve the property of the district, and to assure the health and safety of the students and staff. Ordinarily contingent expenditures are determined by the Board of Education and are subject to certain regulations.

Q: What would the District have to do to develop a contingency budget?

A: The current NYS laws include a new calculated tax levy for each school district. Cherry Valley-Springfield's calculated cap for next year is 0.00%. If a contingency budget happens, the tax levy would remain at 0.00%.

Q: Adopting a transportation plan.

A: The District has worked to create a long-term plan for replacement of buses. This plan creates consistency for replacement, consistency in Aid verse Debt, and a clearer vision for the district moving forward.

Proposed Capital Project

How was the decision made to Proceed with a Capital (Building) Project?

Every five years, schools in New York State are mandated to complete a Building Condition Survey. CV-SCS retained Griffith Dardanelli, an architectural firm, to complete the survey the fall of 2015. The Building Condition Survey studied every aspect our building and grounds, determining any areas that had exceeded their “useful life”, or would within a few years exceed their “useful life.”

In developing the scope of this proposed capital project, the Board of Education and its Building Committee used the data in the Building Condition Survey to determine what should be included in the project that we are now proposing.

In order to continue to protect our district’s investments in our school, and in accordance with the Building Condition Survey, several improvements need to be made to the building and grounds so that our school can continue to provide a safe and efficient learning environment for our community well into the future.

Scope of Project

Throughout this project, infrastructure (electrical, plumbing, heating/ventilation) systems will be improved.

Main Building:

- Exterior masonry & steel restoration
- Reconstruct atrium curtain wall and platform steps
- Bracing at roof deck and at interior walls
- Add water isolation valves
- Improve kitchen (cafeteria) drainage
- Replace restroom plumbing
- Address classroom air intake
- Improve air condition in offices
- Improve HVAC isolation and controls
- Improve lighting in the HS gym
- Replace septic tank

Transportation Building:

- Improve storm water site drainage
- Replace overhead doors at the bus wash bay
- Improve accessibility—exterior and interior
- Reconstruct concrete pad & replace fuel oil tanks
- Replace electrical receptacles at interior columns
- Improve bus wash infiltration system
- Replace heaters in the bus wash bay
- Repair bus “pit” walls
- Address rust on columns and on bus lift

What is the Proposed Cost of the Project?

The proposed cost of the project is \$3,120,000. The cost includes all costs associated with the project, including design costs, construction management costs, fees, incidentals, and actual construction costs.

How will the Project Be Funded?

Cherry Valley-Springfield School’s State Building Aid Ratio is 81.5%. This means that any part of the capital project that is

aidable will be aidable at that percentage. Our project is all aidable items. The District Proposed Capital Project has \$97,470 remaining in EXCEL aid, which can be applied to specific parts of the project that address capacity, energy, accessibility, health, safety, and educational technology. The District also intends to use \$460,700 of capital reserve to the project to reduce local share.

With the use of EXCEL aid and capital reserve, the district will need to issue bonds to fund the remaining \$2,564,830. As the bonds are repaid over a period of fifteen years, the principal and interest will be offset by state aid calculated at the percentage noted above (81.5%). The unpaid portion of the expense is referred to as the “local share,” which will be, on average, \$24,338 per year. An estimated average annual impact per \$100,000 full value property will be \$5.26.


