Superintendent's Message

Dear Parents and Community Members,

The extended winter that we experienced in March has made everyone anxious for spring to actually arrive. It will be interesting to see how the spring sports season plays out. Our first spring concert was wonderful. By the time we have our second spring concert the school year will be headed towards the final push. Here at CV-S students have been busy with academics and extracurriculars. Students have attended Odyssey of the Mind, Brain Game, and have been inducted into Honor societies. The Drama Club production of *Annie* was a special treat. Congratulations to the cast, crew and advisors!

Throughout the school year we have been looking at ways to be more efficient with the resources we have at hand. Our main focus is to raise student achievement, yet we are conscientious of creating an atmosphere where we support the whole child. You will start to begin to hear the term *trauma-sensitive* school. At CV-S we want our students to feel safe, and to learn the skills and strategies to maintain a positive mental health. It will be our focus to start implementing this at our school. Stay tuned for more information on this initiative.

On Tuesday, May 15, we will ask you to vote on the 2018-19 budget. This budget provides us the opportunity to purchase Chromebooks for two grade levels so they can transition into a 1:1 laptop program. The budget supports professional development for the teachers in regards to the new standards. The Next Generation standards in ELA and Math were released this year and the Social Studies framework and the Next Generation Science standards have been updated. We are moving the sixth graders back to the elementary wing. We feel this is a better for the students developmentally and academically. The budget also includes the purchase of two new buses; 60-passenger bus with one wheelchair and a 30-passenger bus. We will continue to include \$100,000 capital outlay project in the budget for minor renovation projects. The next minor project would be the replacement of 4-5 exterior doors throughout the building. The propositions that will be on the ballot are listed within this newsletter, please take a moment to review them. We also have three retirements; one elementary teacher, one physical education/health teacher and our cafeteria manager. We are cutting a part time science/part time LTA position. That position in the budget will be replaced with a sixth grade teacher to support the move of the sixth graders.

Our annual budget hearing is on Thursday, May 3, at 7:00 p.m. in room 145. I hope all will attend and also remember to vote on May 15, from Noon to 8:00 p.m. Our annual Art Show will be displayed in the atrium and hallways along with the second spring concert at 7:30 p.m.

At the budget vote last year the community supported a Capital Project. Right now we are still waiting final approval from the State Education Department. The next step after approval is to put the jobs out to bid. We have completed the fuel tank project at the bus garage and installed 50 interior doors in the main building.

And, finally, I want to take this time to thank you, our community, for supporting the school. We are fortunate to have a community that gives students the opportunities to be lifelong learners. I am striving to make CV-S a better place; one day at a time.

One valuable lesson that Tom learned while attending CV-S is to participate in as many extra-curricular activities as possible. Tom feels that half of the learning he experienced came from outside of the classroom and many of the activities he participated in at CV-S are still passions of his today. These activities have also led to new activities such as long-distance cycling, hiking, beekeeping, music performance, and weight-lifting.

While at CV-S there were many teachers who played many different roles for him while he was growing up that he doesn't feel he could fairly choose a favorite. There were many teachers and all of them cared about me as an individual and were invested in his learning. When Tom thinks about how CV-S students will help shape the future he states that to shape the future students need to do what is right, not what is easy. His advice is you will shape the future by: "Picking up after yourself, showing gratitude and thanks when another person helps you, complimenting genuinely and often, being curious about life and learning, helping others to be curious like you, eating a little less red meat giving assistance to others because it is the right thing to do, not for the sake of reciprocity and buying local." He believes that sometimes, how we respond to the challenges and adversity in our lives is more important than what actually occurred. - **5th Grade:** The 5th grade general music class will further explore jazz concepts such as jazz harmony and improvisation through their already composed blues songs.

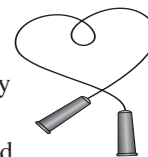
Drama Club (Check out the photos on page 8!)

A Message from the Board of Education

On behalf of the Cherry Valley-Springfield Board of Education I would like to remind you of the upcoming annual budget vote on May 15, 2018. This year's proposed tax levy of 1.91% was reached with a lot of hard work and discussion between the Board of Education and our Administration.

In addition to the annual budget proposition this year we are asking for your approval to purchase a 60 passenger bus with one wheelchair position, to purchase a 30 passenger bus, to purchase a tractor, to expend funds to resurface the gym floor and to establish a Capital Reserve Fund for equipment purchases. You will find the actual propositions within this newsletter.

If you have any questions regarding the budget please be sure to attend the budget hearing that is scheduled for Thursday, May 3, at 7:00 p.m. As always we thank you for your continued support of our District.

Propositions to be on Ballot



PROPOSITION I – Budget

- To adopt the budget as presented in the amount of \$12,992,264, to authorize the Board of Education to levy and collect the necessary taxes.

PROPOSITION II – Buses

- Shall the Board of Education be authorized to purchase two school buses—a sixty passenger that will include one wheelchair position with the total cost not to exceed \$120,000 and a thirty passenger with the total cost not to exceed \$55,000? The source of the funds shall be a tax upon the taxable property of the District to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education.

PROPOSITION III – Tractor

- Shall the Board of Education be authorized to purchase one large garden tractor and necessary attachments with the total cost not to exceed \$25,000? The source of the funds shall be a tax upon the taxable property of the District to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education.

PROPOSITION IV – Floor Repair

- Shall the Board of Education be authorized to expend, during the 2017-2018 school year, funds not to exceed the amount of \$20,000 to repair the high school gym floor? The funds for the project were approved during the 2017-2018 budget vote and would be taken from the Repair Reserves Fund.

PROPOSITION V – Capital Reserve

- Shall the following resolution be adopted? **RESOLVED**, that the Board of Education (the “Board”) of the Cherry Valley-Springfield Central School District, Otsego County, New York (the “School District”) is hereby authorized to establish a capital reserve fund to finance various equipment purchases for the School District pursuant to Section 3651 of the Education Law of the State of New York (the “Fund”); that the Fund shall be known as the “Capital Reserve Fund for the Undertaking of Various Equipment Purchases for the School District,” that the ultimate amount of the Fund shall be not greater than \$2,000,000 (plus interest earned thereon); that the probable term of the Fund shall not be longer than ten (10) years; and that the permissible sources from which the Board is authorized to appropriate monies to such Fund from time to time shall be (a) unappropriated fund balance moneys from the School District’s General Fund authorized by the Board to be deposited in the fund, (b) State aid received as reimbursement for expenditures by the School District in connection with School District capital improvements, and (c) such other moneys from the School District’s General Fund as approved by the voters.

Such applications must be received by the District Clerk at least seven days before the vote if the ballot is to be mailed to the absentee voter, or the day before the vote if the ballot is to be delivered personally to the absentee voter.

Voter Qualifications

A qualified voter is one who is (1) a citizen of the United States of America, (2) eighteen years of age or older, and (3) a resident within the School District for a period of thirty (30) days next preceding the annual vote and election.

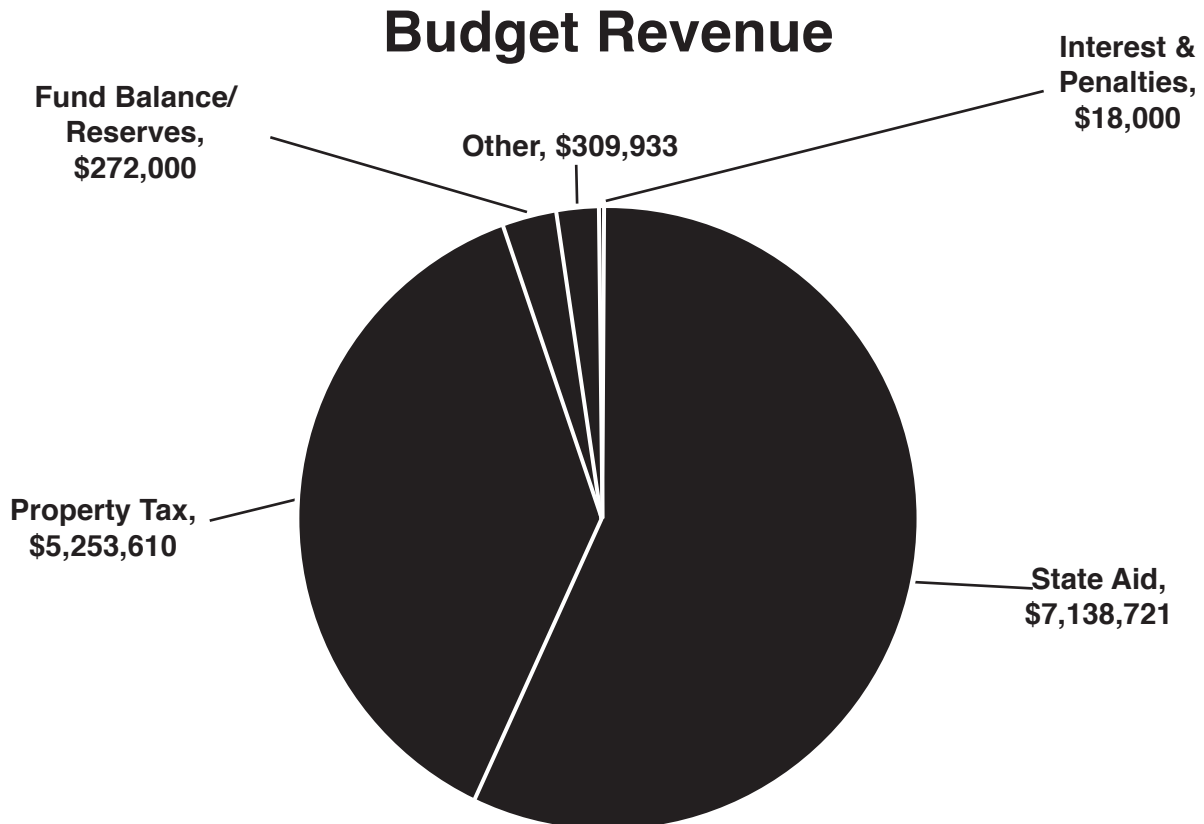

Program Component

The program budget includes those expenses directly related to the teaching of students. Those include teachers, assistants, aides and other professional salaries, BOCES charges, supplies, textbooks, special education costs, health, guidance, co-curricular activities and athletics. This area also includes transportation expenses directly related to the functioning of the bus garage and the operation of the bus fleet. The program budget is increasing by 0.54%

Capital Component

The capital budget includes Operations and Maintenance expenses including salaries, fringe benefits, utilities, and supplies directly related to the cleaning and maintenance of the District's building and grounds. This portion of the budget also includes principal and interest costs related to the borrowing for our capital improvement projects. The District receives 81.5% building aid from NYS for this. Purchases for buses is reimbursed by NYS at 61.5% over five years. \$100,000 transfer to Capital Fund will provide funding for exterior door replacement project. The capital budget is decreasing by 22.15%.

Proposed Budget Q & A

Q: What is the increase in the local property tax levy?

A: 1.91%

Q: Does the STAR program still exist?

A: Yes, the School Tax Relief Program, which is known as STAR provides a partial exemption from school taxes. All New Yorkers who own & live in their home and earn less than \$500,000 are eligible for a STAR exemption on their primary residence. Exemption amounts are shown below. The Equalization rate, set by the State, and assessments set by township, will affect the exception value. Enhanced STAR provides a larger exemption on the primary residence for people over 65 years of age and who earn less than \$86,000. This exemption requires initial online registration with New York State. If you qualify, you will receive a STAR credit in form of a check, rather than receiving a property tax exemption. If you or spouse recently turned 65, or if your income fell below \$86,000 due to changing circumstances, please apply online.

Q: How are your dollars spent?

A: By state law the budget is divided into three categories:

- **Program—74.1%:** This category includes expenses for the instruction and transportation of students.
- **Capital—15.9%:** This category includes capital improvement and operations and maintenance costs.
- **Administrative—10.1%:** This category includes costs for administration, supervision and legal services.

Q: How is education funded at CV-S CSD?

A: State aid covers approximately 55% of our expenses. Property taxes cover an additional 40% and other sources cover the remaining 5%

Q: What is the difference between the State Aid we received last year versus the State Aid we will be receiving this year?

A: The District anticipates receiving approximately 6.7% less aid for the 2018-19 school year. This is mostly from a large reduction in Debt Service.

Q: What has been done to reduce the budget to its present level and limit the taxes?

A: The Board of Education at Cherry Valley-Springfield CSD works hard to balance the needs of the students and the taxpayers' ability to pay. We have put together a budget that is fiscally responsible and that sustains our educational programs. The district continues to be efficient with the following efforts: bringing services back into the district, sharing maintenance and transportation staff, and exploration of grant opportunities.

Q: What happens if the budget is voted down?

A: If the proposed budget is voted down the Board of Education has three choices.

1. They can adopt a contingency budget.
2. Put the same budget before the voters for a second time in June.
3. Revise the defeated budget and put that budget up for another vote in June.

Q: What is a contingency budget?

A: A contingent budget is a budget that includes the minimum funds necessary to operate and maintain schools and educational programs, preserve the property of the district, and to assure the health and safety of the students and staff. Ordinarily contingent expenditures are determined by the Board of Education and are subject to certain regulations.

Q: What would the District have to do to develop a contingency budget?

A: The current NYS laws include a new calculated tax levy for each school district. Cherry Valley-Springfield's calculated cap for next year is 2.55%. If a contingency budget happens, the tax levy would remain at 0.00% .
