We first educated our Board of Education, faculty & staff, and community members of what ARP is, the purpose and how it can be used. The BOE was asked how they would like the money spent. Prior to a meeting an email was sent to faculty & staff asking for their wish list. There were 3 meetings with faculty and staff asking for their input. Literacy data was reviewed to see where our downfalls were in the elementary. This was shared. All lists were shared and we then started to prioritize. A letter was sent to families and posted on the school website asking for their input. A survey was posted on the website and the community was also given the superintendent's email and phone number to contact.

The Superintendent's cabinet took the lists and narrowed them down. About 90% of the items on the list were added to the ARP. As we move through the life of the grant the BOE will review quarterly status of the ARP. The District will continue with a survey each year to the community to receive input on previous spending and additional areas which could also be supported.

Our school district was open all last year, in-person. We are a PK-12 building and we were in-person everyday. Our building used to house 960 students andi¾ now we house 460 students. We have the space to spread out students. Monies will not be used directly for prevention and mitigation purposes. We will be installing a gym divider in the HS gym so that classes may be separate so there is social distancing. HS lunch was in one half of the HS gym last year. We are looking at possibly having to do this again for the 2021-22 school year. The divider will assist in noise reduction and also allow PE class distancing when inside.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Elementary literacy - Benchmark data for reading will be used to evaluate new programs that were implemented to support phonics and phonemic awareness. Fountas and Pinnell benchmark data is reviewed each trimester to target students at risk and also a report is run to see what common areas students are not doing well on, or areas where students are mastering content. Reviewing the 2019 and 2020 data clearly demonstrated that our students cannot rhyme. Purchasing Secret Stories is one example that will target an area our students do not do well on. In order to use the program the way it is intended to be used, our teachers needed PD on how to use this resource.

Professional development for teachers - Secondary focus on grading and assessment. Review quarterly report card data and compare it to previous years' data. More importantly, review new data that shows implementation of standard based assessment. Are students meeting the standards and are they meeting or exceeding mastery on formative tests. Analysis of course syllabi and grading practices by the admin team and a core group of secondary teachers revealed that there are inconsistent grading and assessment practices. Breakdown of class grading was reviewed and focused on the question, "what do these grades tell us about what the student actually knows?" It was clear our teachers need PD on assessing and grading students.

We are a low-income area, so the summer program supports that population of students. Our students deserve a summer program to support SEL and academics. Pair these programs up with our town swim programs to offer full day programs. Students need to be given the opportunities. Many of our at risk students have no place to go in the summer. Offering a summer program that includes academic support and enrichment allows for students to be actively engaged in academics but not in the traditional modality. A summer program has the flexibility to add more hands-on activities and focus on areas where the students need support. Those students who are at risk will be directly invited to attend the program. Data used to determine this will be those students not reading at grade level, students who have attendance issues of absent more than 10%, and/or qualify for free and reduced lunch. Transportation will be provided, breakfast and lunch will be provided and it will be full day so that parents do not have to worry about child care and how they will get their child to the program.

Educators need to be given the tools and resources to better instruct their students. When given these tools we can then better evaluate our programs and see where the gaps are and make adjustments. Each strategy is a level. As we add a level we narrow the gap and we have a clearer picture where a support needs to be implemented.

Focusing on mental health in terms of PD and adding resources allows the district to not put band aids on situations, rather start focusing on the root causes.
