Dear Candidate:

The following is an excerpt from the New York State Education Law:

"Any candidate for election to the board of education, except a candidate for member of the board of a New York City Community School District, shall file sworn statements with the clerk of the school district in which he is a candidate and the commissioner of education setting forth all moneys or other valuable things, paid, given, expended or promised by him, or incurred for or on his behalf with his approval to be filed with the aforesaid clerk and commissioner by any person, firm, association or corporation, to aid his own nomination or election, or to aid or influence the nomination or defeat of any candidate to be voted for at the election. Any candidate for election, if he expended nothing or his only expenditures were for personal expenses which when taken together with the total expenditures incurred by others on his behalf and with his approval do not exceed five hundred dollars, shall not be required to file any statements with the commissioner of education; however, such candidate shall file with the clerk of school district a sworn statement to the effect that his election expenditures did not exceed five hundred dollars."

The New York State Education Law goes on to indicate that the following statements are required. A preliminary statement "must be filed no later than 30 days before the election". A second statement "must be filed no later than five days before the election". The third and final statement "must be filed within 20 days after the election". "If a candidate receives a contribution or loan in excess of \$1,000 after the closing date for the most recent required statement, but before the election, the candidate must report it within 24 hours after its receipt."

Enclosed is the petition you requested and for your convenience the forms required to meet the conditions stated above. The petition and the first statement is due by April 21, 2025, the second statement of expense no later than May 15, 2025, and the third expense form, no later than June 9, 2025.
