#### D. LAND LEASE AGREEMENT

RESOLUTION 4-4-2022

WHEREFORE, at its regular meeting held on August 16, 2018, the Board of Education of the Cherry Valley Central School District adopted a resolution authorizing the District to enter into a lease with Omni Navitas Holdings, LLC ("Omni") for the development of a solar project on a portion of the District's property located at 183 Neilson Road (the "Property") in a form to be approved by the District's Superintendent and its legal counsel and subject to any required approval of the District's voters; WHEREFORE, the voters of the District have authorized the District to lease the Property; WHEREFORE, since that time, GSPP 183 Neilsen Road, LLC ("GSPP") assumed Omni's interest in the solar project; and

WHEREFORE, on behalf of the District, the District's Superintendent executed an Amended and Restated Lease Agreement between the District and GSPP dated February 1, 2022 (the "Lease Agreement") for the lease of the Property for this purpose in a form that had been approved by the Superintendent and the District's legal counsel.

NOW THEREFORE, the Board of Education authorizes the District to enter into an Amended and Restated Lease Agreement between the District and GSPP dated February 1, 2022 (the "Lease Agreement") for the lease of the Property for this purpose; authorizes the Superintendent to execute the Lease Agreement and such other documents as are necessary to effectuate the Lease Agreement; and ratifies any actions already taken by the Superintendent in that regard.
