Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Four students shared their community service experiences, which included helping with Biddy Basketball and helping with various projects through the BOCES National Honor Society. They also shared what they felt they gained from the experience and their future plans. Mrs. Knapp spoke about the NY State testing going well and dates being set for the end of the year activities. Mrs. Georgi spoke about how pleased she was with the special education students and their participation with the NY State testing, CSE meetings are in full swing, and the transition field trip that our Special Education students attended was very informative. Mrs. Wist spoke about the final budget numbers and the proposed tax levy being 1.91%. Mrs. Wist also spoke about the possibility of purchasing chromebooks this year if she has the extra funds that she is hoping to have at the end of the year.

Additions to the Agenda – Correspondence Received

Correspondence Received – President Tabor spoke about an email that the Board members received regarding a special education issue and also he was asked about the possibility of a person receiving an honorary diploma.

Superintendent Climenhaga spoke about a meeting that she attended with the MAC, Delaware and Tri-Valley leagues and the concerns that were shared regarding low enrollments and not being able to field teams, a meeting for grades 5 and 6 was held and the specials are being worked into the schedule, a meeting for attendance was held with the biggest concern with juniors and seniors and a meeting will be held regarding updating the cell phone policy. Superintendent Climenhaga also spoke about the upcoming interviews for the open cafeteria manager position. Mrs. Climenhaga then reviewed the opt out data for the state testing and she was pleased with our low opt out numbers. Superintendent Climenhaga then spoke about National Day of Prayer and meeting at the flagpole and it needs to be student lead, she spoke about being approached from BOCES to possibly lease classroom space and concerns were shared to make sure that CV-S students come first. Mrs. Climenhaga spoke about building project reviews being backlogged at NYS Education Department, the project information was submitted in November but it looks like it will not be reviewed until August. Superintendent Climenhaga also spoke about the new requirement from State Ed. with regards to student instructional time; 180 days in session with the added requirement of 900 hours for elementary students and 990 hours for secondary students. Mrs. Climenhaga then reviewed the goals for the 3rd quarter, she also shared the goals in the team drive. Then Mrs. Climenhaga shared information that she received at a Hot Topics meeting, including school safety, drugs, misconduct and legal advice.

Board of Education Committee Reports – Mrs. Garretson spoke about the Superintendent's Evaluation process and she reminded Board members to be objective and to review the binder that Mrs. Climenhaga is completing. Mr. Lennebacker asked about the Code of Conduct review.

President Tabor recognized the visitors - No one had anything to share.

# RESOLUTION 6-4-2018

RESOLVED, that the Board of Education (the "Board") of the Cherry Valley-Springfield Central School District, Otsego County, New York (the "School District") is hereby authorized to establish a capital reserve fund to finance various equipment purchases for the School District pursuant to Section 3651 of the Education Law of the State of New York (the "Fund"); that the Fund shall be known as the "Capital Reserve Fund for the Undertaking of Various Equipment Purchases for the School District," that the ultimate amount of the Fund shall be not greater than \$2,000,000 (plus interest earned thereon); that the probable term of the Fund shall not be longer than ten (10) years; and that the permissible sources from which the Board is authorized to appropriate monies to such Fund from time to time shall be (a) unappropriated fund balance moneys from the School District's General Fund authorized by the Board to be deposited in the fund, (b) State aid received as reimbursement for expenditures by the School District in connection with School District capital improvements, and (c) such other moneys from the School District's General Fund as approved by the voters.
