Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Four students shared their community service experience, which included helping with the Boys and Girls State Dinner, the CV Outdoor Games, the Veterans Day 5K, the Cherry Valley Food Bank, elderly neighbors, and the Sharon Springs Chamber of Commerce. They also shared what they felt they gained from the experience and their future plans. Mr. Keane spoke about Regents testing and focusing on a strong finish for the 2nd quarter. Mrs. Knapp spoke about the nice long teaching block for the second trimester, student recognition programs are being planned. Mrs. Georgi welcomed Mrs. Utter the new Keyboard Specialist in the CSE/Guidance Office area and thanked Mrs. Whiteman for stepping in and doing a great job when she was needed.

Correspondence Received - None was received.

Superintendent Climenhaga spoke about the exterior door replacement being completed, the bid opening for the Capital Project will occur on Jan. 25th, working out details with the Smart Schools Bond, BOCES has hired a coordinator for the System of Care Grant, State Ed. shows CV-S as a fiscally healthy school, Continuing Ed. enrollment numbers increased by about 100 from last year, and the land lease is still being discussed between the attorneys. Mrs. Climenhaga also shared an update on the spring sports including CV-S offering a late bus at 5:05, uniforms have been decided, and there will be a roll out meeting for parents - one meeting at each school. Superintendent Climenhaga also spoke about Mrs. Adams being inducted into the Section IV Hall of Fame, review school lunch accounts (each month the balance owed keeps getting higher), the initial budget run was released and it looks like CV-S may be up a little bit, though it is too early to have the whole picture. Mrs. Climenhaga also spoke about needing to upgrade classroom furniture, window blinds, etc. from wear and tear through the years - starting with Kindergarten and working up from there. She also spoke about continuing with the light bulb replacements to more energy efficient bulbs, continuing the laptop program to include the 7th & 8th graders, one teacher retirement and possibly one LTA retirement. Superintendent Climenhaga also spoke about the possibility of not holding summer school at CV-S this year and only offering Driver's Education.

Board of Education Committee Reports – Mr. Lennebacker spoke about the Building Committee meeting that was held. There was discussion held regarding the next \$100,00 outlay project and waiting to see how the bid process works on Friday, Jan. 25th.

President Tabor recognized the visitors – A parent asked about the summer school success rate, thanked the Board members for their service and spoke about the upcoming Cherry Valley Food Bank fundraiser that will be held on February 23. Discussion was held regarding Summer school.

The Board did not need to enter into the proposed Executive Session.
