Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Two students shared their community service experience, which included helping with the Springfield Library and Biddy Basketball. They also shared what they felt they gained from the experience and their future plans. Mrs. Knapp spoke about professional development that is planned for the conference day on the 26th, moving forward with PBIS, the after school reading support for the elementary students, and Mrs. Knapp also gave an update on the PTO including info. for their game night that would be held on Friday, Jan. 19th. Mr. Keane reviewed the Tier I and II data for the Academic Intervention Policy, he spoke about the end of the marking period coming up and Regents being held next week.

Correspondence Received – President Tabor spoke about an email correspondence that was received from a parent regarding a suspension from basketball. President Tabor also spoke about a letter that was received from the Administrators Association.

Superintendent Climenhaga spoke about the further review taking place with regards to the Every Student Succeeds Act (ESSA). The fuel tank and interior door projects are set to be completed. There will be a meeting on Jan. 30th with area towns and the new landowner regarding the radio tower. The CVSTA contract is out to be printed. A power outage last week helped the maintenance department find some areas that need to be addressed. The Library Media Center will be hosting a Maker Faire in May and there will be five weeks (one night per week) of community family night time where families can come and spend time at the Library. The Crisis Team has spent time redesigning and reviewing their plan. Superintendent Climenhaga spoke about an Academic Achievement Grant that is available and BOCES spoke about using a grant writer and including other area schools. Mrs. Climenhaga and Mrs. Wist have been working with Forecast 5 regarding long-term financial planning. Superintendent Climenhaga shared a report that shows area schools, including CV-S, enrollment declining and poverty increasing. Mrs. Climenhaga also shared the initial budget overview for 2018-2019.

President Tabor recognized the visitors - A parent requested the Board's approval to allow her son to participate in modified football at the Cooperstown Central School. A student was congratulated for winning the CV-S Spelling Bee.

WHEREAS that in reliance upon the Architect's advice it finds the Project qualifies as Type II under

SEORA, and that the Project will therefore not have a significant adverse impact on the environment.
