Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

Hannah Sheldon, the student liaison, spoke about Student Council holding Spirit Week before break and they hope to have the new mascot costume in March. Mrs. Wright spoke about grades 3-8 computer based state testing simulation being held this week and grades 7-8 will be next week. Mrs. Wright spoke about attending a Science of Reading Conference, reviewing two ELA platforms at the upcoming conference, reviewing attendance, supporting an internship person one day per week, and the first round of APPR's are completed. Mr. Keane was not able to attend so Mrs. Wright shared his update regarding the Student Voice Student Choice presentation (check and trophy) on Jan. 5th, attendance training sessions are being held, Regents will be held next week, See Something Say Something training later this month and Coaches vs Cancer and Senior Night on Jan. 27th. Mrs. Wist spoke about all the department budget meetings that have been held, and she shared her concerns with the Save Harmless being eliminated in the budget this year from the State which means about 800,000 Foundation Aid was cut which is not at all what anyone was expecting. Mrs. Wist also reviewed the overview and summary of changes for the 24-25 budget. Mrs. Santillan, Mrs. Seales and Mrs. Shaffer shared their Math Department presentation which included information reviewing course offerings, the transition in the standards, Middle and High School updates, resources and Math Honor Society. Mrs. Wright shared a presentation regarding PAX, which is a program being used in the elementary grades that helps with the student's self regulation, self control and self management.
