Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Six students shared their experiences with volunteering, what they got out of it and their future plans. Mr. Brophy spoke about everyone doing their part so we can stay in person and PreK and K recruiting information will be placed on the website soon. Mr. Keane spoke about how proud he is for everyone's resilience, the priorities remain the same, and wrapping up the first half of the school year. He also spoke about being out for a couple of weeks because of his upcoming total knee replacement.

Correspondence Received - President Tabor noted a thank you that was received regarding a person being able to complete their student teaching.

Superintendent Climenhaga spoke about the Food Drive serving over 350 families tonight and it is impressive how efficiently it works, they were done by 4:25. Around 15 adults and 15 students helped and a member of the Sharon Springs Rotary watched the process with the hopes of having a Drive held in Sharon Springs. Mrs. Climenhaga reviewed the number of COVID cases, 6 students, 3 staff and 1 teacher, the good news is that they are not linked to inside the school. The entire school community is doing a great job supporting the district to keep everyone safe. Superintendent Climenhaga then reviewed the fiscal and environmental reports that she received and she shared them in the Boards team drive, the reports were very good. Mrs. Climenhaga also spoke about the discussion being held with the area BOCES Superintendents regarding the Juneteenth holiday and how it impacts the school calendars. The exit interview was held with the State Comptroller and the issues were minimal. There is a required communicable disease plan that needs to be approved and in place by April 1st. A budget state run has been shared and it doesn't look that different from past runs but there is not a lot of concrete information, looking at a rollover of what we have and a 0% levy again. Right now looking at purchasing two buses and adding distance learning with the help of a grant so the cost would only be 9,100 for the distance learning. Conversations are being held with the teachers association regarding distance learning.
