Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

One student shared her community service experience, which included helping with the Boys and Girls State Dinner, the Veterans Day 5K, babysitting for teachers on days that they had to attend faculty meetings. She also shared what she felt she gained from the experience and her future plans. Mrs. Georgi spoke about training that is occurring for School Tools, the new student data system that will be used beginning on July 1st. Mrs. Georgi also shared that the new staff, Mrs. Brust and Mrs. Utter, are wonderful. Mrs. Knapp spoke about PARP coming up in March, with lots of fun activities planned. Mr. Keane spoke about the Silver Medal Awards Ceremony being held on Feb. 15th, the long academic stretch after winter break, eligibility and no transportation available for the indoor track event on Friday, Feb. 15th. Mrs. Wist reviewed very basic and conservative budget figures. The possibility of including the purchase of three buses (1 small wheelchair and 1 large wheelchair and 1 large) and updating two elementary classrooms was reviewed. Discussion was held regarding summer school. Cobleskill Richmondville charges 350/course. CV-S spent over 20,000 on summer school last year. It was decided that there would be a 5 student minimum to hold the class at CV-S.

Public Hearing for review of Policy 5300 Code of Conduct was held from 7:28 PM to 7:29 PM - no one spoke.

Additions to the Agenda - K. Lennebacker stated potentially.

Correspondence Received – Mr. Lowry spoke about the good experience he had when he attended Narcan training through the Continuing Ed. Program. President Tabor read a thank you from Mrs. Drake regarding the use of the school building.

Superintendent Climenhaga spoke about the bids for the Capital Project being lower than expected which is good news, she spoke about the possibility of continuing to include another 100,000 project in the 2019-2020 budget, the fire inspection was completed with no issues, on Feb. 1st the facility and staff attended an informative presentation regarding transgender, the Smart Schools Bond bids to go out in May with the work to be completed in Sept. & Oct., All County Concerts were Feb. 2 and Mar. 2 also on Mar. 2 Mrs. Adams will be inducted in the Section IV Hall of Fame. Superintendent Climenhaga will be attending a meeting for the System of Care Grant, she also spoke about having some very challenging primary behaviors though there are no placements available for students and they are too costly so she would like to look into hiring a behavioral specialist for the rest of the year. There was a shift in personnel with not replacing an aide position to help with the cost of the behavioral specialist. Mrs. Climenhaga spoke about the parent meetings for spring sports that would be held on Feb. 28, 5:00 in Sharon Springs and 6:00 in Cherry Valley-Springfield, teh Cafeteria Audit went very good and Mrs. Climenhaga is still researching how to complete the grant so all of our students can receive free breakfast and lunch. Superintendent Climenhaga also spoke about the Board's goals being shared in the team drive along with the eligibility data.
