Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board in the Pledge of Allegiance.

There were three students who shared their experiences with volunteering, what they got out of it and their future plans. Lydia Lusk, the student liaison, shared the students' excitement for the pep rally on Friday and the upcoming winter break. Mrs. Georgi spoke about meeting with the special education team, reviewing individual instruction plans (IEP), training for IEP writing, CSE Chairperson meeting looking at recruitment needs. Mrs. Wright spoke about the 100th day of school celebration, 5th & 6th grade choir, Kids Heart Challenge, the LEAF vaping presentation for the 5th and 6th grade students, PreK-6 PAX training is almost set, weekly phone meetings with Branching Minds. Mr. Keane spoke about the pep rally tomorrow, the upcoming sectional basketball games, vaping presentations being given to all grade levels, the 3rd quarter is really important for curriculum planning because of the two vacations, the Scholar Recognition display, Work Based Learning, All County (Mar. 2 & 4), Spring Sports (Mar. 13) and Mrs. Wist shared that the first aid run has been released, Mr. Timbs will be at the March 16th Drama Production (Mar. 24-26). Board meeting to share the long range financial analysis, State Ed. and Child Nutrition shared the concern with excess funds in the cafeteria fund so the following purchases will be made - a kettle, cold line server, small milk cooler and a warming cabinet. Mrs. Wist then reviewed the budget packet that she supplied to the Board members, including an overview and summary for changes for the 2023-2024 school year, percent changes (1, 1.5, 2, 2.395 and 3), and she reviewed the three components including Administration, Program and Capital. Mrs. Wist has locked in fuel and diesel pricing but not propane. Mr. Tabor asked about the BOCES figures and Mrs. Wist spoke about the numbers being based on programs.
