Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

No student reps were present. Mrs. Wright shared February student recognition, therapy dogs being in the building, PAX training (student self-management) with parents and a thank you to Springfield Library for their assistance, PARP will begin and a family night will be held on March 22nd, and Mrs. Wright is continuing to work on completing the required observations. Mrs. Wright shared Mr. Keane's report: staff training for the new promethean boards is scheduled, and the calendar was broken down for maximum student growth. President Tabor spoke about the building condition survey and Ms. Snyder stated that she is waiting for some quotes. Marilyn Marshall, representing the Springfield and Cherry Valley Libraries, submitted petitions for the May ballot which President Tabor read - the request for \$60,000 to be split evenly between the two libraries. Discussion was held and Ms. Marshall shared her contact information.

Correspondence Received – President Tabor spoke about the Cherry Valley and Springfield Libraries submitting a petition at the Feb. Board meeting for the May budget vote.

Superintendent Snyder spoke about the All County Music Concert and student field trips being held. School Based Health is still being reviewed. Information is being shared with secondary students to see if they are interested in a trap shoot team. A bus broke down (only1.5 years old) so it is under warranty. The Diversity, Equity & Inclusion meeting will be held March 16th. The 2022-2023 school calendar is almost set, the solar company reached out to the Town of Cherry Valley, waiting for a few quotes for the building condition survey, the CVSTA (Teacher's) contract is almost ready to be printed, the CRRSA Grant has one more year of funding for the summer program, and there is an opening for a second shift cleaner. Ms. Snyder is looking for direction regarding the spring sports teams with regards to game/practice location, team names, and uniforms. Discussion was held. Mrs. Wist reviewed the Administrative, Program and Capital components of the 22-23 budget. Mrs. Wist also spoke about the 4% increase in dental and health insurance and medicare reimbursement is 150,000 plus this year and is looking to be 170,000 plus next year. She is reviewing the purchase or lease of a phone system as the current system is becoming outdated. Mr. Lowry asked about BOCES not appropriately using funds and if it will impact us, Mrs. Wist does not believe it will.

President Tabor recognized the visitors and read a brief statement regarding the process with the public speaking during the Board meeting. A visitor shared her concerns with masks and quarantine and would like to return to normalcy. President Tabor hopes to see changes in the near future.
