Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Five students shared their experiences with volunteering, what they got out of it and their future plans. Mrs. Georgi spoke about team effort and everyone doing what they need to do. Mr. Brophy spoke about the second trimester ending and report cards being mailed out, students getting outside with the nice weather, lots of projects are being worked on in the classrooms and ELA and math were the main focus and now social studies and science are being worked on as well. Mr. Keane spoke about preparing for exams, thanked everyone while he was out with his knee replacement, working on making many plans for the many upcoming events - honor society inductions, live streaming games, drama club, graduation, prom and awards ceremonies. Mrs. Wist spoke about purchasing two buses if voter approved, fund balance and revenue concerns and the state aid runs are expected to come out the end of March.

Superintendent Climenhaga spoke about the positive case with a staff member today and the need to use a snow/emergency day tomorrow and an early dismissal on Monday (only breakfast will be served, no lunch). Mrs. CLimenhaga said there was great teamwork with everyone helping everyone out. Superintendent Climenhaga then spoke about the Department of Health meetings that she is still attending and the encouraging results from the anonymous vaccine survey that she sent out to faculty and staff. Mrs. Climenhaga then spoke about the upcoming BOCES annual meeting on April 1st, the required state testing and Regents exams, and the three snow/emergency days that are still available. Superintendent Climenhaga then spoke about the STAR information that she shared with the Board of Education and she would like to share it with the public. Mrs. Climenhaga spoke about removing Distance Learning from the 2021-2022 budget plan because BOCES wasn't able to secure the grant - only one school in NY was awarded the grant. Superintendent Climenhaga spoke about 2 fans being allowed to attend the home and away soccer games, the games will also be streamed. Mrs. Climenhaga sent a copy of the building condition survey to the Building Committee members. The Ed Law 2D audit was held this past week and there will need to be some policy updates as a result. Mr. Keane is reviewing the Code of Conduct, which needs some updates. Superintendent Climenhaga spoke about the Governor's requirements on outdoor events and renting a tent for graduation, which the seniors will help pay for. It is also the hope that the tent will be able to be used by many events throughout the week such as PreK graduation, award ceremonies, prom, etc. Discussion was held regarding fundraising and class trips, with the need for further discussion this summer.

Board of Education Committee Reports – K. Lennebacker spoke about needing to start reviewing the building condition survey in late summer or early fall.

President Tabor recognized the visitors – A visitor shared her concern with limiting class trips, she wondered about changing the two fans that will be allowed at the soccer games and she liked the idea of the prom being held under the tent. Another visitor shared information regarding the 1619 Project, transgender athletes and snow days.
