Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

One student shared their experiences with volunteering, what they got out of it and their future plans. Mr. Kenae spoke about everyone doing a great job following procedures and there will only be one week left of the quarter when we return from spring break. Mr. Brophy spoke about report cards having been mailed out and he also spoke about some families not looking forward to breaks in school as they can be difficult for some families.

Additions to the Agenda - Adjustment needed as there were two RESOLUTIONS 10-4-2021.

Correspondence Received - None to share - nothing received.

Superintendent Climenhaga spoke about the COVID numbers in Otsego Co. The numbers are still not going down and gatherings in homes are a concern. Mrs. Climenhaga spoke about being approached by individuals about pigeon shooting at the Milford Rod and Gun Club and she has requested more information. Superintendent Climenhaga then spoke about a new scholarship donation that is being set up at CV-S that is currently valued at \$312,000. Mrs. Climenhaga then spoke about the spring sports, including baseball, softball and track, that will be coming up and requesting less funding for baseball and softball from Sharon Springs because they only have one student for each team. Mrs. Climenhaga spoke about having three emergency days left and the calendar for the next school year, waiting to receive guidance from the Governor regarding Prom, and the state assessments will not be given to the remote students. Mrs. Climenhaga then spoke about the 2021-2022 budget being updated and funds being received in the last few days. Superintendent Climenhaga also spoke about instruction focusing on reading and math, professional development to be held this summer and an online clothing store is being worked on. President Tabor asked if the funds that had been received were relief funds and Mrs. Climenhaga stated that the funds were not new money. Mr. Lowry asked about the prom refund and the answer was yes, the class received their refund. Mrs. Erkson stated that Sprout Brook has a Rod and Gun Club so there is no need to travel to Milford.

President Tabor recognized the visitors – A visitor shared that trapshooting help may be available, questioned if the modified softball players would be able to play with the modified baseball players since there are currently not enough girls playing and stated that members of the community have said that they will help with the organizing of the prom.
