Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

Two students shared their experiences with volunteering, what they got out of it and their future plans. Ethan All, the student liaison, spoke about the Student Council holding the pep rally and spirit week and hoping to have the new mascot within the month. Mrs. Wright spoke about the Girls on the Run and Let Me Run programs, 5th Grade hosting the Living Museum, upcoming field trips, a book swap, PreK registration, State Testing and the Summer Program. Mr. Keane was not able to attend the meeting so Mrs. Wright shared his report. In secondary, the end of the semester was last Friday, the Co-Valedictorians and Salutatorian were announced, Honor Society inductions are coming up as well as State Testing. Mrs. Oram and Mr. Lyford shared information regarding the music department program including stannards and events/happenings throughout the year.

Correspondence Received – Superintendent Snyder shared a resolution that was approved by Otsego County recognizing the Girls Varsity Basketball Team for their historic 2023-2024 season.

Superintendent Snyder shared information from the cafeteria - Mrs. Davidson attended a food show and Chobani will be delivering and donating 80 cases per month of yogurt to CV-S. The plan is to use 30 cases for the backpack program. CV-S is very grateful for the donation. Ms. Snyder spoke about the Annual BOCES meeting that was held last Thursday, workplace violence training has is occuring, there are two people interested in becoming bus drivers now to find training available for them, the fall soccer numbers are being reviewed and there will be no school on April 26th (an emergency give back day). Superintendent Snyder then spoke about the possibility of the Governor reinstating the Hold Harmless. Mrs. Wist shared a budget packet and spoke about maintaining a tight budget. Things have been pulled out of the budget along with reducing five positions. The difference between a 2% and 2.8% tax levy is just over 44, 000 but really a position is over 50,000 including all benefits and required taxes, etc. The idea is to try to not cut programs but still need to focus on reducing. Discussion was held if Hold Harmless was reinstated and if it is then the need to use reserve funds from TRS and ERS would not need to happen along with ARP funds. Discussion was also held regarding the 2% versus 2.8% tax levy. The Board of Education members all shared that they wished to have the tax levy be 2% not 2.8%. President Garretson thanked Mrs. Wist and Ms. Snyder for their work on the budget.

President Garretson recognized the visitors, no one had anything to share.

Shall the Board of Education of the Cherry Valley-Springfield Central School District be authorized to (1) establish a capital reserve fund to be known as the Technology Capital Reserve Fund for the purpose of renovating and improving School District facilities for the purpose of technology related improvements and to finance the acquisition of furnishings, wiring, computers, equipment, or apparatus related thereto; (2) deposit into such fund the ultimate amount of \$5,000,000; and (3) annually deposit into the Technology Capital Reserve Fund such portion of the General Fund, unallocated fund balance, state aid reimbursement, other reserves, such other monies as the voters may direct, and/or other legally available funds of the School District in an amount determined by the Board of Education up to the maximum authorized amount. The probable duration of this Technology Capital Reserve fund is ten (10) years. Motion carried unanimously.

RESOLUTION 24-4-2024

Proposition V- AUTHORIZATION of ESTABLISHMENT OF CAPITAL RESERVE FUND 2024

Shall the Board of Education of the Cherry Valley-Springfield Central School District be authorized to establish a capital reserve fund to finance construction, reconstruction and renovation projects of the School District pursuant to Section 3651 of the Education Law of the State of New York (the "Fund"); that the Fund shall be known as the "Capital Reserve Fund 2024 for the Undertaking of Various Building Projects of the School District," that the ultimate amount of the Fund shall not be greater than \$10,000,000 (plus interest earned thereon); that the probable term of the Fund shall not be longer than fifteen (15) years; and that the permissible sources from which the Board is authorized to appropriate monies to such Fund from time to time shall be (a) unappropriated fund balance moneys from the School District's General Fund authorized by the Board to be deposited in the Fund, (b) State aid received as reimbursement for expenditures by the School District in connection with School District capital improvements, (c)such other moneys from the School District's General Fund as approved by the voters, and (d) any remaining balance in the current Capital Reserve Fund upon expiration? Motion carried unanimously.

Motion made by A. Aramini, seconded by E. Johnson to enter into Executive Session to review matters leading to the employment of particular individual(s), employment history of particular individual(s) or corporation(s), review collective negotiations pursuant to Article 14 of the Civil Service Law (the Taylor Law), review recommendations made by the Committee on Preschool Special Education and the Committee on Special Education. Motion carried unanimously.
