Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Three students shared their experiences with volunteering, what they got out of it and their future plans. Mrs. Georgi spoke about holding the second week of CSE meetings and better participation through zoom as parents don't need to take time off of work. Mr. Brophy spoke about the much needed spring break, holding grade level meetings for looking back and planning, the two hour delay causing the 3-6 ELA tests to be moved to Monday and the second grade students being remote since Monday, April 19th. Mr. Keane spoke about seventh and ninth grade transition nights being held virtually, 7-8 ELA tests will be given tomorrow morning and the report cards will be in the mail tomorrow. Mrs. Wist spoke about the preliminary audit happening the second week in May, working to update the long range plan with Forecast 5, submitting the final claim for the Smart School funds the end of next week and the one time Federal COVID stimulus money that will need to be applied for but no set guidance with how the funds can be spent. Some ideas that have been mentioned for spending the funds are summer learning, air filtration systems, ways to focus on learning gaps. Mrs. Wist stated that there has not been a lot of changes to the budget from what she has been reviewing with the Board and the tax levy change is 0%.

Correspondence Received – President Tabor spoke about receiving contact from one parent regarding a student matter for executive session and Mrs. Garretson spoke about receiving an email regarding a football request.

Superintendent Climenhaga spoke about the first positive COVID case with an elementary student, the Otsego Co. Department of Health offering to come to the school for a vaccination clinic for 16-18 year olds but there needs to be a minimum number, and Dave Bliss has been in touch to say that Co. Hwy. 54 road work will be done this summer. Mrs. Climenhaga reviewed a newspaper article that was in the Daily Star regarding the Comptroller's Audit and discussion was held regarding long range financial planning, policies and fund balance. Superintendent Climenhaga spoke about the Governor's guidance on events - including graduation, prom, athletic awards, honor societies, PreK graduation, and class night. Mrs. Climenhaga spoke about the ideas for the federal stimulus monies including garde level gaps and providing a lot for students. Discussion was held regarding graduation outside under a tent and the number of people that will be allowed to attend. Mr. Keane stated there will be a meeting with the students next week to share their ideas.

Board of Education Committee Reports – President Tabor spoke about the Superintendent's Evaluation form being in the binders and returning the completed forms to the May 6th Board of Education meeting.

President Tabor recognized the visitors – A visitor shared her happiness that sports are being played and the morale of the students being up, the concern with low spring sports numbers and also a concern with a coach.
