Meeting called to order at 7:00 PM by President Tabor.

President Tabor led the Board and audience in the Pledge of Allegiance.

Four students shared their community service experiences, which included helping with the Legion, babysitting during faculty meetings, being elves for the Festival of Trees, PARP and the After School Program. They also shared what they felt they gained from the experience and their future plans. Two students also thanked the Board for their support for the winter indoor track program. Mrs. Georgi spoke about the behavioral specialist starting on Monday, School Tool training taking place and the CSE meetings being held. Mrs. Knapp spoke about the long list of end of the year activities, the math state assessments coming up and the upcoming interviews for the Elementary Teacher opening. Mr. Keane spoke about letters being sent home to parents of seniors regarding important upcoming dates, the upcoming state testing, report cards coming out, and high school night workshops. Mrs. Wist spoke about final year end dates, completing the budget newsletter and postcard and the Governor possibly approving a Retirement Contribution Reserve Sub-Fund.

Additions to the Agenda - RESOLUTIONS 15-4-2019 through 16-4-2019 and RESOLUTIONS 19-4-2019 through 21-4-2019

Correspondence Received – President Tabor spoke about a letter that he received from a support staff retiree regarding medicare. President Tabor also read a voter proposition that was received and he also read correspondence from the school's attorney in regards to the proposition. The attorney recommended having the board review the matter and to act to reject the proposition because the proposition is not a power reserved to the voters. A. Garretson shared a concern that she had received regarding cars passing buses on Alden Street at dismissal time and Superintendent Climenhaga responded.

Superintendent Climenhaga spoke about still working on free and reduced lunches for next school year and sending out all calls for low or negative balances for lunch accounts. Mrs. Climenhaga then spoke about graduation taking place in the CV-S gym this year. Superintendent Climenhaga spoke about five students struggling with completing the volunteer requirement for seniors. Discussion was held and the Board members felt that it was a requirement that had to be completed in order to graduate since it is a policy. Mrs. Climenhaga spoke about supplying transportation for the Baseball Hall of Fame on July 21st and our students being able to sell water at the parking lots for class fundraising that day. Mrs. Climenhaga shared in the board team drive NYS budget highlights, the highlights for quarter 3 goals and updated eligibility data. The Spring Concert included a song where Grades 5-12 all played together, Leonard Bus has supplied the district with a loaner bus at no charge, and the Safety Committee is working on 3 levels of evacuation drills.

Board of Education Committee Reports – President Tabor asked that the members return their completed Superintendent Evaluations to the Meeting on May 9th.

President Tabor recognized the visitors – A parent asked what the status was on indoor track and Superintendent Climenhaga responded that it is in the budget for next year. Superintendent Climenhaga's biggest concern is the transportation piece and being short on drivers. Discussion was held. A parent shared their concern with restrooms in Sharon Springs and the late buses.

The Board did not need to enter into the proposed Executive Session.
