Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

One student shared their experience with volunteering, what they got out of it and their future plans. The student representative was not in attendance (softball game). Mrs. Wright spoke about completing the state testing, summer school, PAX classrooms, Branching Minds platform being fully operational, and all but five observations completed. Mrs. Wright spoke on behalf of Mr. Keane, as he was attending a conference for Work Based Learning. A practice US History Regents will be given on May 5 with the actual test on June 1 and secondary is ramping up for crunch time. Mrs. Georgi spoke about the Committee on Special Ed. meetings being held, observations are complete, there are data deadlines coming up and the Individual Educational Plans are being prepared to be sent out. Mrs. Wist spoke about gearing up for the end of the school year, the state budget came in fine, the new breakfast carts are working out really well, there will be an increase in minimum wage over the next three years, Community Eligibility Provision has been approved in the state budget with more farm to school flexibility and the interest rates are looking good for the district (currently 4.87%). Mrs. Hanson shared lots of exciting information from the essentials team.

President Garretson opened the 2023-2024 budget hearing at 7:23 PM.

Superintendent Snyder reviewed student enrollment and the Capital, Administrative and Program components of the budget and the contingency requirements for the 2023-2024 budget. Discussion was held on the need for new reserve accounts, with the plan to have a public vote in the fall along with the capital project vote. President Garretson closed the budget hearing at 7:49 PM.

Superintendent Snyder spoke about the possible capital project and the need for a roof scan. Ms. Snyder is suggesting a total roof scan because the cost is over \$2,000 for just the trouble spots or \$5,000 for the entire building. The BOCES National Honor Society indications were held last week, Mr. Collins completed training to become a certified Director of Transportation, Ms. Snyder attended a Rotary meeting last week with Dr. Huber, the April newsletter was sent out last week, BOCES grades came late which affected a number of things, Valedictorian (J.Lusk) and Salutatorian (C. Benson) were announced, Mrs. Wist and Ms. Snyder spent a lot of time on a zoom regarding the desk review (audit), there will be a smaller scale mobile food pantry on June 5th - the teacher's association will be handling the details, the backpack program has not had many helpers and the food pantry is looking to have some storage of backpack items here at the school, approval for the bus garage lift has been granted from NY State Education, teacher appreciation is next Tuesday, Nurses appreciation is Wednesday and cafeteria staff is tomorrow, information is still being gathered regarding an agriculture program and the end of the year activities calendar is out.

President Garretson recognized the visitors - No one in attendance.
