President Tabor led the Board and audience in the Pledge of Allegiance.

Superintendent Snyder spoke about the upcoming requirements with electric buses and zero emissions and her concerns with meeting these goals. The end of the year activity dates are shared in the drive. Ms. Snyder then reviewed the school based health using 90,000 from capital reserve and 80,000 for the outdoor learning center. Superintendent Snyder then spoke about the difficulty in getting quotes for the possible capital project.
