Meeting called to order at 7:00 PM by Vice President Lenneabacker.

Correspondence Received – None received. However, A. Garretson shared a big thank you for all of the communication that is being sent out.

Superintendent Climenhaga spoke about end of the year dates being sent out to parents, faculty and staff. The last day of school will be June 18th with classes ending on June 16th. Details for Graduation are still being worked out. Please keep in mind that all dates are subject to change. The budget vote will be held via absentee and as of now there will be close to 400 ballots mailed. Postcards were mailed to notify people. A budget flier will also be mailed. As of now, the plan is to end the meal plan on June 17th. A drive thru food pantry to be held in the school parking lot on May 29th for Cherry Valley, Springfield, Richfield Springs and Sharon Springs communities. Superintendent Climenhaga spoke about attending back-to-school webinars and what that could look like. Communication from the Governor and State Education has not been consistent but Mrs. Climenhaga spoke about trying to be transparent with everyone. Superintendent Climenhaga then spoke about the budget and the 0%, 1% and 1.5% figures that were shared with the Board of Education.

Mrs. Wist then spoke about being as conservative as possible and maintaining what we can for students. Mrs. Wist plans to monitor and use caution. Discussion was held regarding the need to purchase three buses and the reason beyond that is because three leases are being returned. Discussion was also held regarding the plow truck and caravan and they will only be purchased if they absolutely have to be purchased.

The source of the funds shall be a tax upon the taxable property of the District to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education. RESOLUTION 17-5-2020

Shall the Board of Education (the "Board") of the Cherry Valley-Springfield Central School District, Otsego County, New York (the "School District") be authorized to transfer \$80,000 from the Capital Reserve Fund for the Undertaking of Various Equipment Purchases for the School District to the District's General Fund (during the current fiscal year of the District) for purposes of applying such amount towards the cost of the acquisition of passenger caravan and a plow truck as approved by the qualified voters of the School District voting at the Annual Meeting of the School District held on June 9, 2020, and that the School Business Official is hereby authorized and directed to undertake all actions necessary to implement this transfer. Motion carried unanimously.
