Superintendent Climenhaga spoke about the parent meetings having been positive and they will benefit everyone, the faculty and staff meetings that were held, the intent to homeschool letters being received and requests for remote learning. There are so many situations with NYS and Federal laws and everyone's rights. Starting Monday, August 24th teachers will be allowed in the building from 8-4 Monday - Friday; to work in their classrooms. Committee work is being done with remote learning planning, the conference days are being planned and a certified Google trainer has been coming in to work with the faculty. The hope is that 5-6 grade students will have their laptops in September. However, the students in grades K-4 there is no set date for when they will arrive. About 300 families attended the drive-thru food pantry that was held today. Beginning in September they are hoping to have the drive-thrus to be held after school. We are expecting to have our September state aid check to be cut by 20%. Some cost saving measures include not replacing a math teacher that is on leave and not replacing two retiree positions of an LTA and an aide. Mrs. Garretson asked about sub procedures. Mrs. Climenhaga also spoke about there is no liability on the school's part with regards to COVID-19.
