President Tabor led the Board and audience in the Pledge of Allegiance.

Mrs. Wright also spoke about PBIS, the positivity project, and STEM to be taught in the elementary grades. Mr. Keane spoke about being happy to have everyone back and glad to be able to offer after school activities and late bus and the soccer senior nights will be-boys - 10/1 and girls - 10/5. Two students shared their experiences with volunteering, what they got out of it and their future plans.

Superintendent Climenhaga spoke about the CRRSA Grant being approved. However, we are still in need of hiring a school psychologist and an LTA under the grant. The ARPA Grant has been submitted. The opening of school has been going well. There were only two positive high school student COVID cases this week. Mrs. Climenhaga spoke about the required testing for those not vaccinated to be done at CV-S once per week, about 85% of the CV-S staff has been vaccinated. Adult Education will be starting with karate on Monday and Thursdays. The After School Program will begin on Monday, Sept. 20th and will be held Monday - Thursday. The land lease contract is being updated. The work on county highway 54 is taking longer than expected. A Board member is needed to serve on the Diversity, Equity and Inclusion Committee. The meetings will be held every 4-6 weeks with about 4-6 meetings. Superintendent Climenhaga also spoke about the theme for the 21-22 school year is "Positivity".
