Section IV has decided there will be no fall sports season, try to hold three sports seasons starting in January with conditioning maybe starting in Nov. 30th. The comptroller's audit was positive, CV-S is very good at what and how we do things. The next drive thru pantry will be held Sept. 24th at 3:30 with the senior class helping as well as staff. The nature trail is being worked on with the plan for three outdoor classrooms, thanks to Nate Waterfield. With regards to the budget, our summer state aid payment was cut by 20% but our September payment will not be cut, we are still trying to be responsible. The Department of Health trumps the State Ed. and CDC with regards to how to handle COVID-19 symptoms, etc. So far symptoms are the biggest issue and we have to send home anyone with symptoms. There are lots of new reports to complete including one that has to be completed daily by 3:00 regarding enrollment, etc. Mrs. Climenhaga thanked everyone for their help and guidance and she is very happy the students are back!
