Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board in the Pledge of Allegiance.

The Oath of Office was administered to new Board member Megan Bosc.

Two students shared their experiences with volunteering, what they got out of it and their future plans. President Garretson welcomed Hannah Sheldon, the student liaison, and she shared information from Spirit Week. Mrs. Wright spoke about the testing that has been occurring, evaluations are beginning and continuation of de-escalation training at BOCES on the conference day on Oct. 11th. Mr. Keane spoke about being glad that the drop/add period is over and getting ready for tomorrow when the yondr pouches will begin being used. Mrs. Wist spoke about the first payroll of the new school year, tax collection, the audit is being completed, letters of intent are being discussed for EV Buses (large and small), information has not been shared from the Rockefeller Study yet and interest rates dropped with the expectation that they may drop again. There were no Board Committee reports to share. Ms. Snyder then shared information about the NYS Regionalization Initiative which is not about merging schools but using resources with area schools. Then Ms. Snyder spoke about the NYS Graduation Measures Initiative which is just beginning and it involves the portrait of a graduate. Ms. Sheldon also mentioned using the CV Community Center for the prom venue and the Class Advisor is asked to share that request as well.
