Superintendent Climenhaga spoke about Laurens CSD approving Winter Track, she spoke about the land lease vote with an informational night to be held on Oct. 18th and the vote to be held on Oct. 25th. Mrs. Climenhaga spoke about Mrs. Urban securing a grant for the Fast Forward Reading Program, the positive opening conference day (action plans, self care & student of concern team), Open House was well attended, CV-S has a foreign exchange student this year, the Masters Banquet for the students that attended Boys and Girls State, the cafeteria is up and running with homemade and farm to table foods, the enrollment figure is at 490 students, and ELA and Math State Tests data has been embargoed until Oct. 4th.
