Meeting called to order at 6:39 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

The audit committee meeting was held with a representative from the Bonadio Group present and the Board of Education members. Motion made by G. Lowry, seconded by A. Aramini to adjourn the committee meeting at 6:50 PM. Motion carried unanimously.

Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

Five students shared their experiences with volunteering, what they got out of it and their future plans. The students and caregivers left the meeting after they shared their experiences. Ethan All, the student liaison, spoke about the activities Student Council has or will be helping with including the pep rally, elementary students getting an ice cream treat, and Veterans Day Breakfast to be held on Nov. 9. Mrs. Wright spoke about safety patrol being up and running, Mrs. Hanson connecting with a school in India for the 5th and 6th grade students, fire safety day was held on Oct. 13th, math benchmarking is to be reviewed with the Bridges Math Program going very well, the 3-8 grades NY Test results will be mailed out soon to guardians, and Mrs. Wright is looking to expand on some volunteer opportunities. Mr. Keane spoke about the five week reports being sent out, partnering with Utica University for a teacher prep program, and the upcoming Varsity Girls and Boys soccer sectionals. Mrs. Wist shared spoke about the finished audit review process, the ST-3 has been submitted, working with Leonard Bus Sales regarding the electric bus grant opportunities, working with Mr. Davern for a new firewall system because the current system was doubling in cost, working with Mrs. Davidson with her child nutrition audit, 85% of the taxes have been collected, ESSA & MOE reporting, and financial literacy opportunities for the staff. President Garretson spoke about the Audit Committee meeting that was held at 6:30 prior to the regular Board meeting. Mrs. Frank shared her report regarding what activities students are completing in the Library Media Center and Ms. Bullinger and Mrs. Russell shared their report regarding how they are supporting students with learning literacy. Ms. Snyder mentioned that the stimulus monies have helped to fund the literacy programs that are being utilized.

The meeting was held on October 19, 2023 in the School Cafeteria at the Cherry Valley-Springfield Central School Building.

Superintendent Snyder thanked the Board of Education for their service in recognition of Board Appreciation Week. Ms. Snyder then spoke about the Capital Project and staying with BCA Architects with a public vote to be held in February. Ms. Snyder is expecting more project information at the beginning of next week. Ms. Snyder then shared that the School Based Health Center (SBHC) ribbon cutting will be held on Dec. 7th at 1:00PM. The do not travel roads list was reviewed with Mr. Collins with the plan to review it again in July. The Safety Committee met regarding the upcoming training on Nov. 2nd and is planning to have an evacuation drill in May. Plans are in the works for a military wall, for graduates from 1988 to present. Discipline and suspenses has been a big topic at the State Ed. level. A plan for electric buses is being worked on. There are changes in the Civil Service process with less than five years of service. Ms. Snyder attended the Cherry Valley Town Board meeting regarding basketball practice at the Old School and the insurance is set for CV-S. CV-S will host a program and breakfast on Nov. 9th for area Veterans. Ms. Snyder also spoke about email bomb threats that were sent out to schools across NY state on Wednesday, Oct. 18th. CV-S did not receive such an email. Discussion was then held regarding electric buses and working with Leonard Bus Sales. The plan is to purchase two electric buses for the 2025-2026 school year with the full fleet being electric by 2035, which as of now is the New York State mandate. Further discussion was held regarding charging stations and training.

President Garretson shared information regarding public comment at Board meetings.
