President Garretson led the Board and audience in the Pledge of Allegiance.

The audit committee meeting was held via zoom with a representative from the Bonadio Group and the Board of Education members. Motion made by R. Tabor, seconded by A.Aramini to adjourn the committee meeting at 6:46 PM. Motion carried unanimously.

Meeting called to order at 7:00 PM by President Garretson.

Public Hearing for the review of Policy 5300 Code of Conduct-5300.30 Prohibited Student Conduct. No discussion was held. Motion made by R. Tabor, seconded by A. Aramini to adjourn the Public Hearing at 7:02 PM. Motion carried unanimously.

Two students shared their experiences with volunteering, what they got out of it and their future plans. The students left the meeting after they shared their experiences. Lydia Lusk, the student liaison, spoke about the activities Student Council has or will be helping with including Homecoming, Halloween dress-up and Veterans Day Breakfast. Mrs. Wright spoke about the Pride Store up and running, Community Meetings being held, class trips being taken, and thanking the area Fire Departments for Fire Safety Day last Friday. Also, the science curriculum is being reviewed, Math RTI is up and running, she has attended Principal's Academy, the therapy dogs are in the building, a PTO meeting was held tonight with theri movie night being held tomorrow night. Mr. Keane spoke about the five week reports being sent out, Student Voice Student Choice, and the upcoming Varsity Girls and Boys soccer playoffs. Mrs. Georgi spoke about working on evaluations, meeting with staff, auditing the indicators process and follow-up training. President Garretson mentioned the building walk through that the Board did and it would be talked about later. Mr. Keane and Mr. Davern shared information from the Technology Plan and what is happening within the building for IT. Mrs. Wright shared information from the 3-8 State Testing and talked about it being a guide for what curriculum is used. Mrs. Benson, the co-advisor for the Class of 2023, spoke about the trip that the Senior Class would like to take to Ohio and Niagara Falls in June. Mrs. Wist shared spoke about the finished audit review process, the ST-3 has been submitted, 83% of the taxes have been collected, the checks will be cut to the Springfield and Cherry Valley Libraries, the healthcare workers COVID bonuses have been submitted, the first 2023-2024 budget meeting was held today, ESSA reporting, and lots of grant reporting is being completed. President Garretson thanked Mrs. Wist for her work and ethics and all that she does, because of the good audit report.

Superintendent Snyder thanked the Board of Education for their service in recognition of Board Appreciation Week. Ms. Snyder then spoke about Open House being well attended, attending a Building Project Conference, presenting at the BOCES Board of Education meeting and maybe trying to use highlights like they do at their meetings. The Crisis Team met, the Social Worker stated on Monday and the open positions are being reposted. Ms. Snyder then shared the Oct. 4th School Based Health Center (SBHC) results of 126 yes and 76 no, she spoke about miscommunication and needing to use more detailed information. As a result of the vote, Bassett will be starting an Advisory Committee with more information to come. New York State Education has completed the first review and it is already on to the second review for SBHC. A security audit/safety review was held and overall CV-S is in very good shape. The Board members had completed their building and grounds walk through and reviewed the priority list. The bus lift looks like it will need to be an emergency project as it can't wait for the fall 2023 capital project vote. There will be a RESOLUTION that needs to have Board approval for the use of Capital Reserves. The priority list has been reviewed with the architect and pricing will be needed. Ms. Snyder also spoke about working on filling the open coaching positions.
