Meeting called to order at 7:00 PM by President Garretson.

President Garretson led the Board and audience in the Pledge of Allegiance.

Public Hearing for the review of Policy 5300 Code of Conduct-5300.55 Corporal Punishment. No discussion was held.

Two students shared their experiences with volunteering, what they got out of it and their future plans. The students and caregivers left the meeting after they shared their experiences. Ethan All, the student liaison, spoke about Student Council helping with the Veterans Day Breakfast, looking into a different mascot custom and the Senior Citizen dinner that will be held on Dec. 5th. Mrs. Wright spoke about the positive feedback regarding our students on field trips, college students being in elementary classrooms, the morning running program for students in 3-5 grade, a thank you to the Student Council for the ice cream treats for Halloween, the Halloween parade was well received, the targeted literacy program with data review and The Wizard of Oz will be presented tomorrow night. Mr. Keane spoke about the secondary teachers receiving new laptops, the basketball season has started with the parent meeting being held tonight, report cards will be sent home tomorrow, and the Save Promise Club is up and running. Mrs. Wist spoke about the single audit being complete, training was held for student treasurers and advisors, exploring options with tractor replacement, closing out the bus lift and School Based Health Center projects, completing lighting around the bus garage, working with Mrs. David son on her Child Nutrition audit, more funds available to the cafeteria and looking into purchasing another breakfast cart, financial literacy opportunities for the staff, working with Mr. Davern on a new firewall system and antivirus and 89.65% of the school taxes have been collected. Mr. Collins shared his report regarding the state of the fleet and fuel usage. Ms. Waterman and Mrs. Schecter shared their report regarding the History classes that are being taught, the Seal of Civic Readiness and the National History Honor Society. President Garretson mentioned that Ms. Snyder will address the Building Committee Report (Nov. 2nd meeting) in her Superintendent's Report.

Correspondence Received - An email for review in executive session.

Superintendent Snyder then spoke about the School Based Health Center opening very soon and the ribbon cutting ceremony being held on Dec. 7th at 1:00. Information from the State Education Department was shared regarding the Blue Ribbon Graduation and different pathways for graduation. The information is being shared in the Board's shared drive. The FFA paperwork was signed today, so that process is in the works. The early dismissal on Nov. 2nd for the active shooter training had very positive feedback. The next step is to educate parents and students. The Capital Project timeline is being reviewed with a possible public vote to be held in February. Ms. Snyder is expecting more project information including a window study to be completed. President Garretson spoke about the issue of not being sure on the dollar figure that the public will vote on. CV-S hosted a program and breakfast on Nov. 9th for area Veterans, the Save Promise Club is starting up and the Say Something Program is a new online program that CV-S is taking part in. The major benefit to the program is a 24 hour hotline for sharing concerns. Superintendent Snyder spoke about the employee booster breakfast that is scheduled for tomorrow, early dismissal on Tuesday, Nov. 21st at 2:00 PM, there is a light issue in the auditorium that they hope to be fixed by the upcoming concert and she also reviewed the goals with the updates shared in the share drive.

President Garretson shared information regarding public comment at Board meetings.
