There were 38 guests for the Veterans Day Assembly and Breakfast, Ski Club will be joining ODY at Royal Mountain and ODY will cover the bus costs from ODY, the System of Care Grant is now in year two but they are lacking two social workers so year three will now be free instead of paying 50%, there are many sports uniforms that have accumulated through the years so there will be a surplus resolution at a future Board meeting. In regards to the Capital Project - the heating system is still being worked on and the bus garage has the DEC approval and is moving forward with the water drainage concerns. The Smart Schools Project is waiting for equipment and they hope to be done by the end of December. Superintendent Climenhaga spoke to Dr. Kjolhede regarding School Based Health and it was decided that the Board would like to invite Dr. Kjolhede to the Jan. or Feb. Board of Education meeting. Mrs. Climenhaga has asked Mrs. Wist to attend the December Board meeting to discuss special education, busing and budgeting. Superintendent Climenhaga also reviewed the Board goals and shared the updates in the team drive, andMrs. Climenhaga also requested that she be able to attend the NYSCOSS Conference in March.
